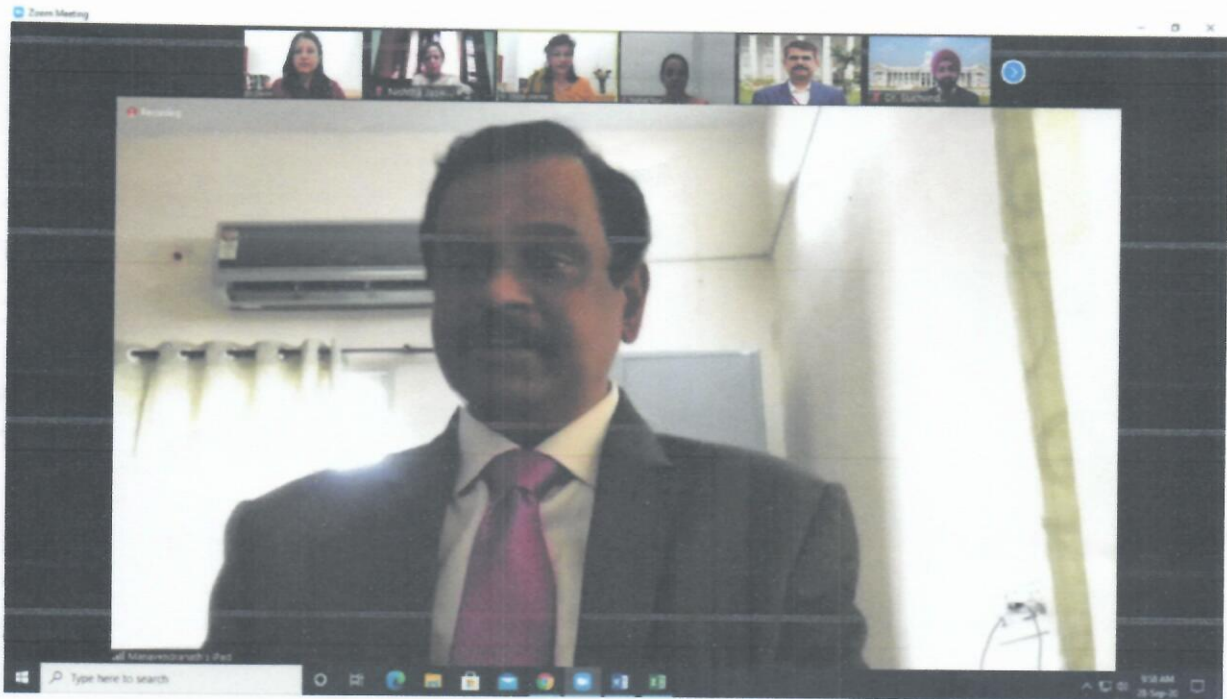

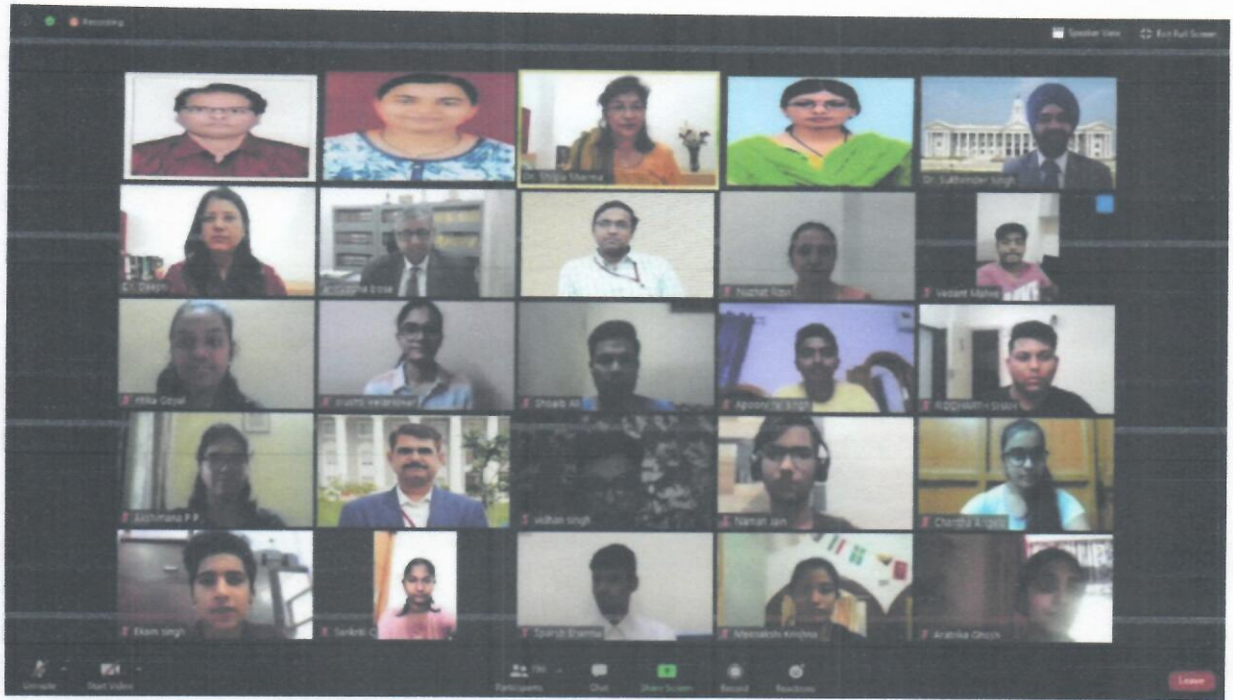
**Hon'ble Shri Justice Aniruddha Bose, Judge Supreme Court of India, delivering the inaugural address.**



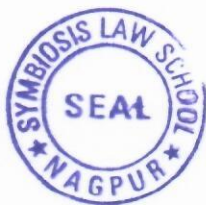
