## Alumni Lecture Series on the topic "Introduction to Project Finance" 23rd July 2022

The Placement Cell of Symbiosis Law School, Nagpur organized a Webinar on the topic "Introduction to Project Finance" on 23rd July 2022 at 4:00 PM. The distinguished speaker for the webinar was Mr. Abir Lal Dey Partner at Saraf & Partner Law offices, Mumbai & Co-presenter Mr. Aroop Das, Senior Associate Saraf & Partner Law offices Mumbai. The webinar commenced with the introduction about the Hon'ble Guest Speaker Abir Lal Dey & Mr. Aroop Das. Dr. Sukhvinder Singh Dari, director SLS, Nagpur welcomed the guests.

The Guest Speaker addressed the students by introducing them to the much sought-after world of project financing. Mr. Abir Lal Dey was kind enough to begin the session with the rudimentary but absolutely essential lesson of what the term "project finance" and the practice thereof actually entails. After tackling the question of "what is project finance?", Mr. Abir Lal Dey and Mr. Aroop Das swiftly proceeded to shed light on the underlying rationale behind project financing and its major correlation with heavy infrastructure projects. This effectively laid a strong foundation for a nuanced discourse relating to project finance whereby the students learned about the types of project financing and also, the types of security interests that are involved in project financing. Following this, Mr. Aroop Das specifically listed out and explained all the relevant financial documents that are required in project financing. The webinar ended with an interesting discussion on due diligence and its importance in relation to project financing agreements. Mr. Aroop Das also elaborated on the general significance of corporate due diligence, the dos and don'ts

while performing due diligence which was also undoubtedly a generally valuable lesson that the students themselves would be able to implement in the beginning of their professional careers.

The webinar was followed by a Question Answer session, The Guest Speaker patiently answered to all the questions which were being asked by the inquisitive minds.
