- Students pursuing undergraduate law degree (3 year program/5 year program) from the institutions all over the country are welcome to submit their registration forms.
- The teams are requested to send an e-copy of the registration form along with the travel plan to [mca@slnagpur.edu.in](mailto:mca@slnagpur.edu.in)
- The teams are requested to remember the important dates and follow the deadlines meticulously.
- The teams are requested to hand over hard copies (5 sets) of their memorials, Registration form and travel plan during the registration.
- Accommodation shall be provided from 12:00 noon 31st January, 2020 to 3rd February, 2020. In case of extension of stay, the participants will have to bear extra expenses incurred on accommodation and travel.

## **AWARDS**

- The team that scores the highest in the Final Round shall be declared the "Winners" and shall be awarded a trophy and a certificate of merit.
- The other team that qualifies to the Final Round shall be declared the "Runners up" and shall be awarded a trophy and a certificate of merit.
- Best Speaker shall be determined on the basis of the highest average marks obtained in the preliminary round, and shall be awarded a trophy and a certificate of merit.
- Best Memorial shall be determined on the basis of the highest marks obtained in the memorial round, and shall be awarded a trophy and a certificate of merit.
- Every participating team shall be awarded 'Certificate of Participation'.
- No 'Certificate of Participation' shall be granted to those teams who have not qualified the memorial round.

\*Gifts, Prizes given by sponsors, if any, shall be additional to what has been mentioned above.

## **FEES AND PAYMENT**

- Registration fee is Rs. 5,000/- (Rupees Five Thousand Only inclusive of GST), to be paid after the selection of the memorial. The registration fee is inclusive of accommodation (31st January, 2020 to 3rd February, 2020), food (Breakfast, Lunch & Dinner from 31st January, 2020 to 3rd February, 2020).
- It is exclusive of the travel from the campus to the airport/railway station. It is the sole responsibility of the teams to arrange for their travel when they are leaving from the campus.
- Registration fee is to be paid by wire transfer only.
