Please read and understand the instructions mentioned below before you proceed for registration for admission to Master of Laws (LL.M.) at Symbiosis Law School, NAGPUR.

Introduction:

Application Procedure:

Candidates aspiring to join LL.M. offered by Symbiosis Law School, NAGPUR, Constituent of Symbiosis International (Deemed University) have to take the common, mandatory All India Admission Test (hereinafter referred as AIAT), which consists of Written Test (70%) and Personal Interview (30%).

Please remember, Candidate applying for SLS-NAGPUR will have to pay application fee @ 1250/- which is required to be paid at the time of filling of application form.

Selection Procedure:

1. Candidates aspiring to join LL.M. offered by Symbiosis Law School, NAGPUR, constituent of Symbiosis International (Deemed University) have to take the common, mandatory All India Admission Test (hereinafter referred as AIAT), which consists of Written Test* (70%) and Personal Interview** (30%).
* AIAT will include objective and subjective written test to assess the teaching aptitude, research aptitude, legal aptitude and basic legal knowledge. It shall include questions

from the following areas: Research Methodology, Legal Reasoning, Legal Aptitude, Jurisprudence, Constitutional Law, Indian Penal Code, Public International Law, Human Rights, Indian Contract Act, Company Law, Family Law, Environmental Law etc.

** Personal Interview is intended to test the Personal Attributes, Fitment, Work Experience, Publications and Statement of Purpose.

Note: You are requested to bring a Statement of Purpose (SOP) not more than (250 words) and two references (one page each) from the Head and Supervisor/Professor of your Institute/ College at the time of appearing for the AIAT on 9th June, 2019.

2. Candidates will appear for AIAT and PI as per applicable schedule, in a given case. Final Merit list shall be drawn on the basis of AIAT Score (70%) and Personal Interview (30%) performance.

Eligibility:

Three or Five Year LL.B Degree from any Indian or Foreign University recognized by the UGC with at least 50% marks or equivalent grade [45% for SC/ST Candidates]. Candidates who have appeared for the final year LL.B examination may also apply.

Intake:

The total intake is 10 seats per specialization.

Scheduled Caste: 15%

Scheduled Tribe: 7.5%

Differently Abled: 3%

Nagpur Domicile: 25%

- Meaning of 'Nagpur Domiciled' Candidates for admission to PG programmes:

PG programme: 'Nagpur Domiciled' means persons, who are domiciled in Nagpur for a period of 5 (five) years as on the date of commencement of the academic year, and who have graduated from or are appearing for the qualifying examination of Nagpur University before admission to the programme.
