#### **DAY 1 – 25/07/2022**

Session Three – 2 pm to 4 pm – In the afternoon session, students were given a gist of the Company law in practice by **CS Rahul Takwani**.

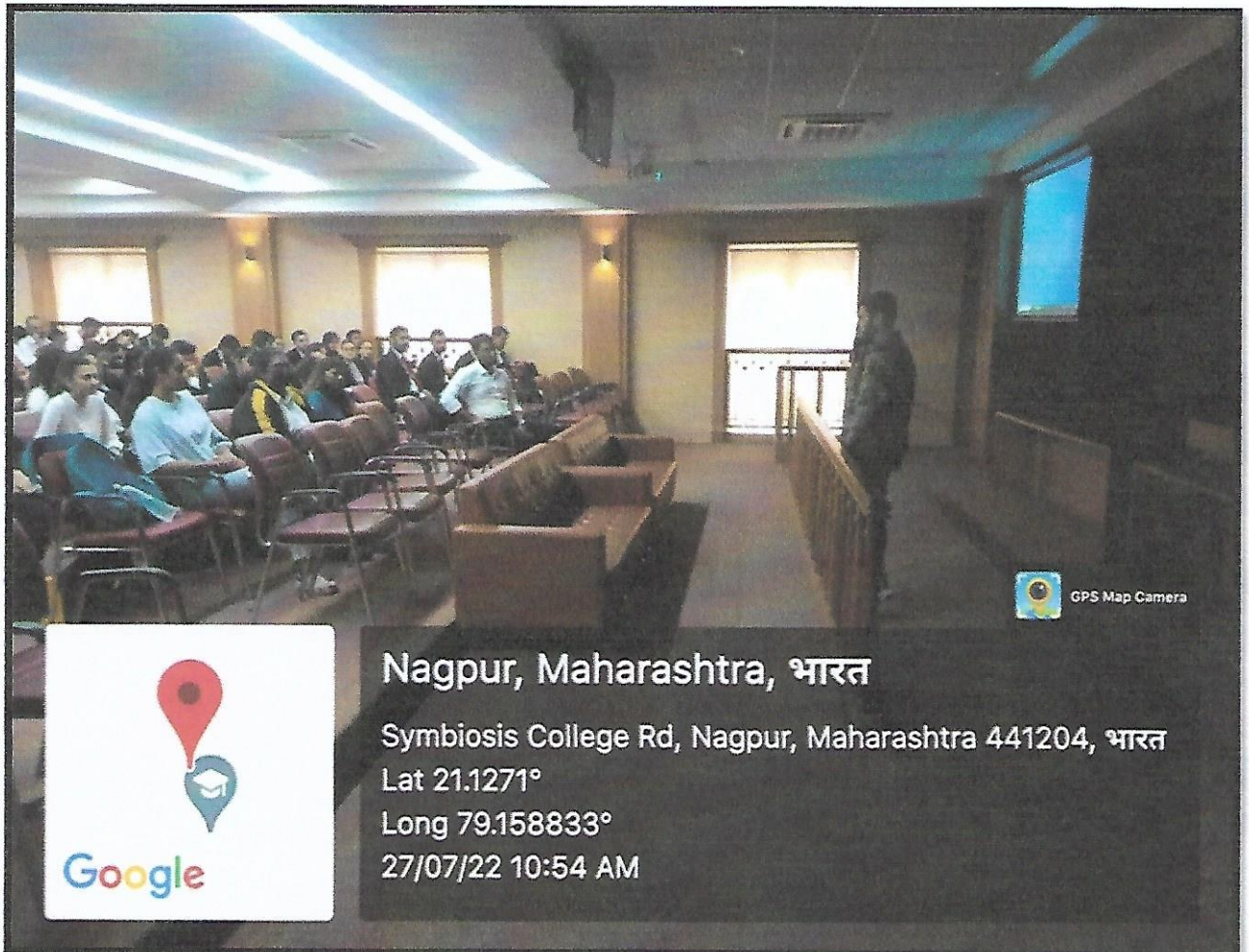


**DAY 6 – 30/07/2022**

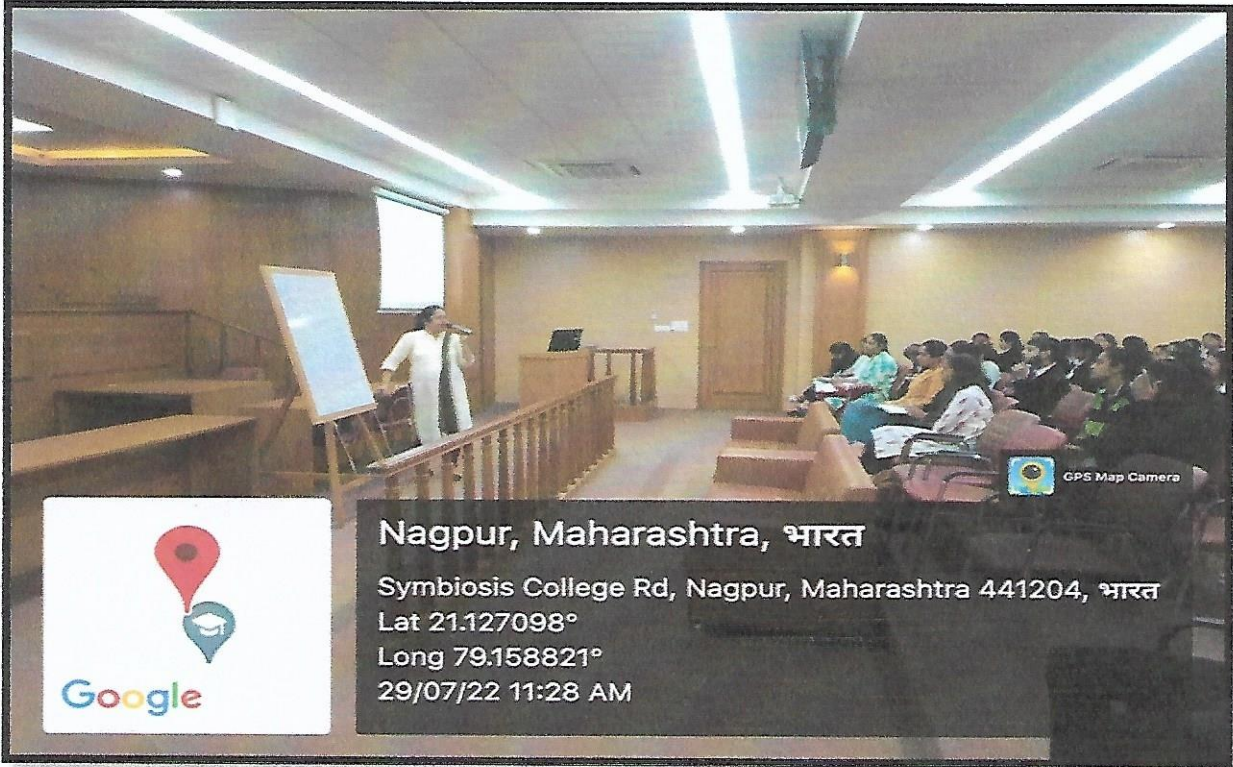
