Orientation Workshop on "Basics of ADR"

In continuation to its commitment to provide the students with opportunities and under the able guidance of Dr. Sukhvinder Singh Dar, Director of Symbiosis Law School, Nagpur, the ADR Cell of SLS-Nagpur organized an exhaustive three days training session on 'Basics of ADR', in which the student members of ADR Cell were exposed to a new perspective about ADR and how to go about managing an event in a more practical way.

The main objective of the workshop was to make the members armed enough to be able to lead in the aspects of organizing successful events and competitions. The training sessions were conducted by the experienced resource persons from the respective field – Mr. Rohan Gulati and Adv. Vivek Joshi.

Adv. Vivek Joshi who is associated with PSL Advocates and Solicitors, New Delhi as an associate and who has headed the ADR Cell of his college in his academic years along with **Mr. Rohan Gulati**, who is currently a final year law student from SLS – Hyderabad.

The resource persons had exhaustively divided the training session contents among themselves and delivered them very effectively to the members of the cell.

On first day of the training session i.e. on 21.10.2021, the Mr. Rohan and Adv. Vivek, dealt with introducing the students to ADR and its current position in current times, very briefly. The content from this session exposed the members of the cell to the practicality of ADR in contemporary times.

Following the first day session, on second day i.e. on 22.10.2021, the resource persons dealt with the important skills required for organising an event. Their systematic and practical approach along with immense emphasis on soft skills and


importance of team work helped us understand the need of extensive ground work that is required on every aspect of managing an event.

Not just dealing with the topic on a theoretical forefront, the sessions were followed up with a mock mediation simulation on third day of the training session i.e. on 23.10.2021, on a mock mediation problem, made by the resource persons, that were circulated to the members. The members were exposed to the practical aspect of how mediation works and were also given a feedback by the resource persons to better themselves through volunteering in this mock simulation.

Undoubtedly, their in-depth knowledge, skill sets, techniques and methodology have helped participants to gain a new perspective and gave them enough confidence to organise events and get college to the forefront.

The workshop was planned and executed by the faculty in charge of the ADR Cell, Dr. Shilpa Sharma, Assistant Professor, Symbiosis Law School, Nagpur along with the constant guidance from Dr. Sukhvinder Singh Dari, Director of Symbiosis Law School, Nagpur.
