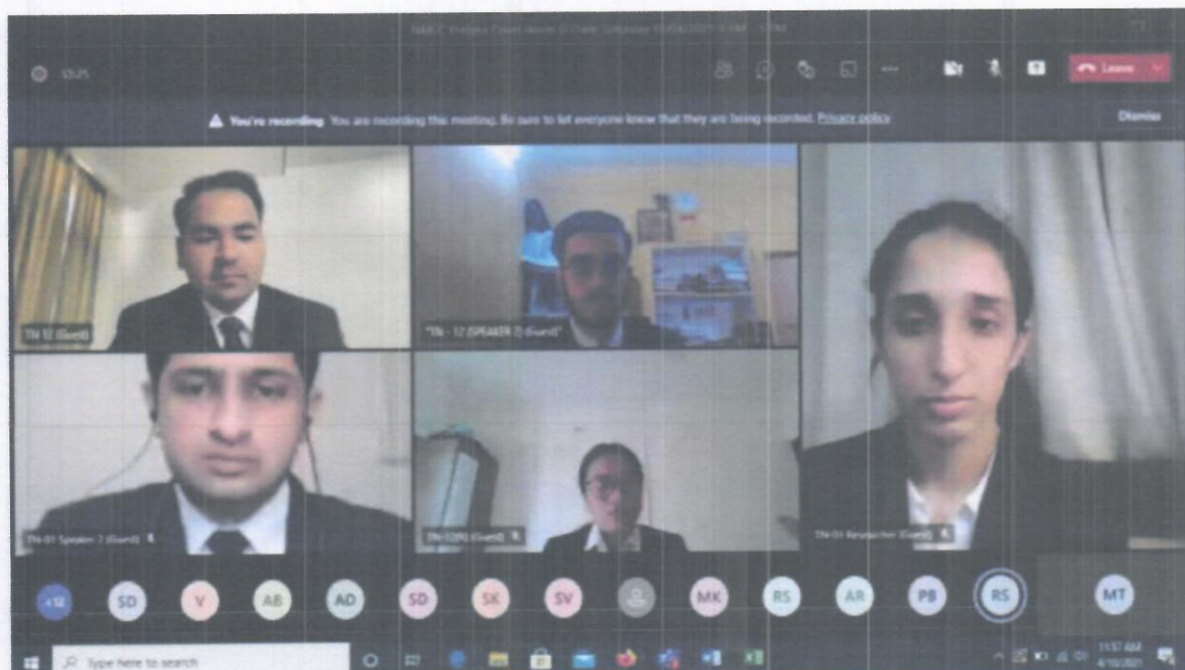

9th April to 11th April, 2021

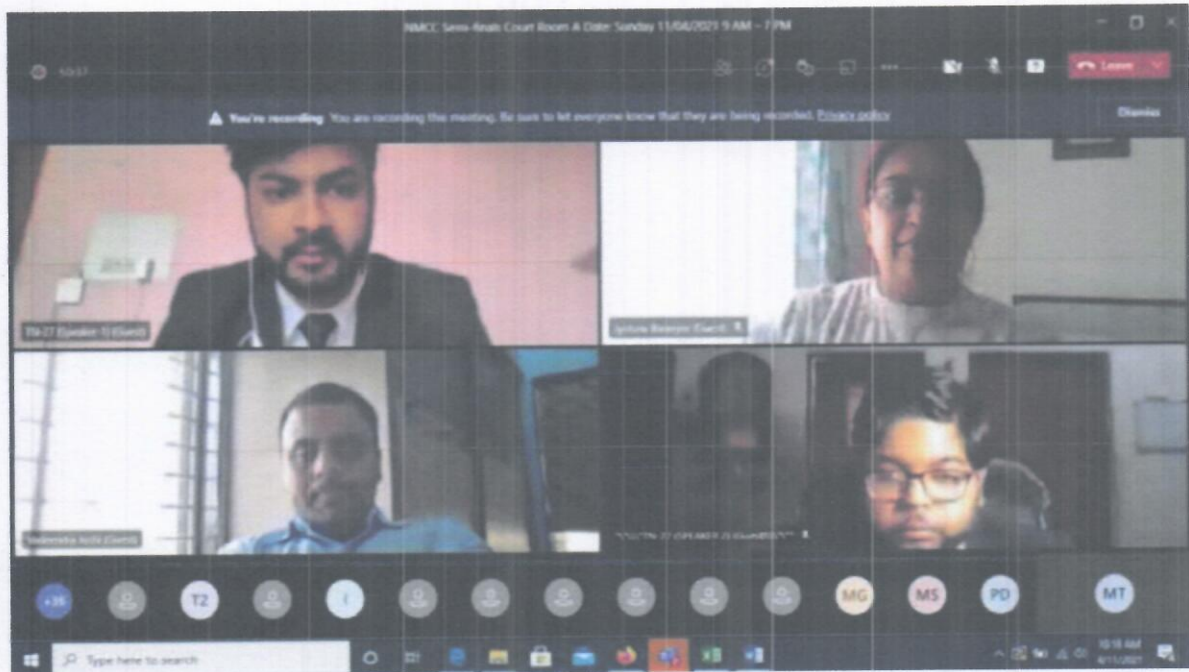

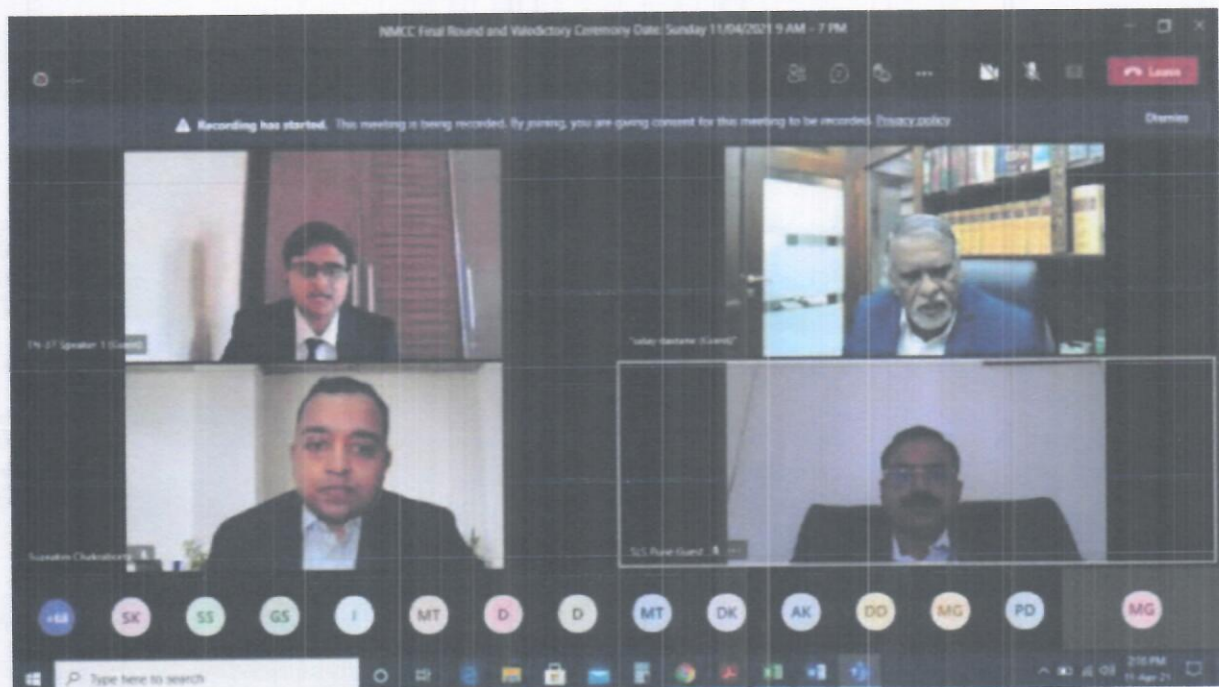

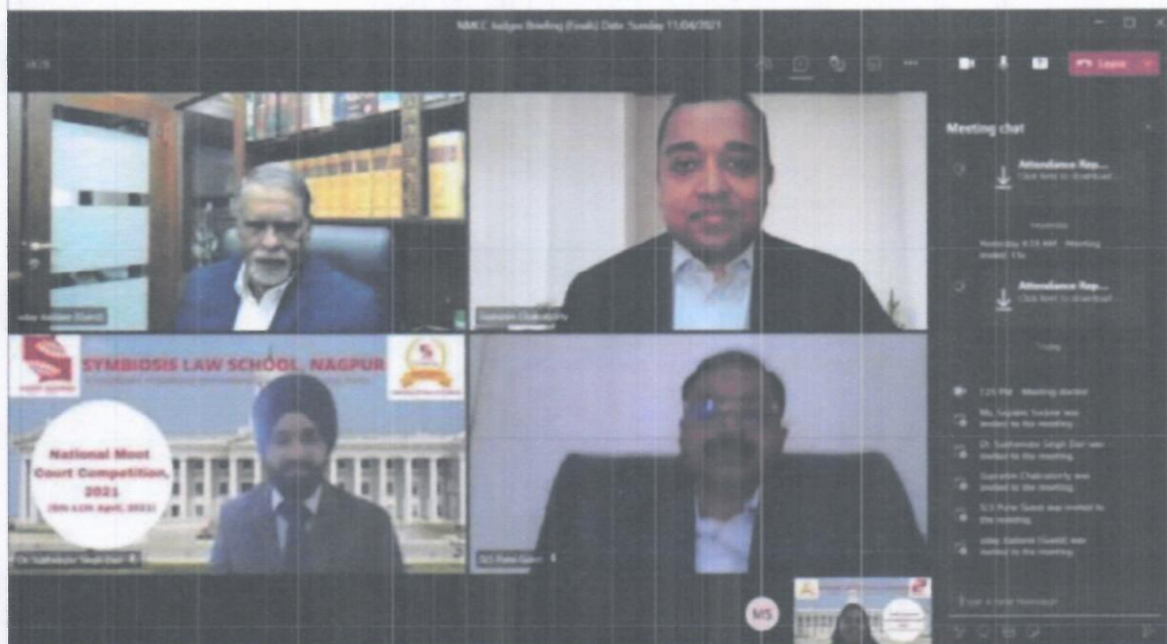
NMCC-2021 Preliminary Round
