NOTIFICATION

WHEREAS, Symbiosis Law School, Nagpur, constituent of the Symbiosis International (Deemed University) Pune has announced the National Moot Court Competition, 2023 to be held in association with the Competition Commission of India, from **31st March to 2nd April, 2023** to enable law students from all across India to participate and showcase their majesty over law and legal principles in a moot court competition;

THEREFORE, the Moot Court Association of Symbiosis Law School, Nagpur, hereby makes the following rules, namely: -



CHAPTER I

1. Short Title and Commencement:

These rules may be called 'NMCC Rules, 2023'. They shall come in to force from the date of publication, on the official website of Symbiosis Law School, Nagpur www.slsnagpur.edu.in. The rules are reviewed annually and are subject to change. Reliance should be placed only on 'NMCC Rules, 2023' and not on any previously applicable rules.

2. Definitions:

In these rules, unless the context otherwise requires,

1. **'Bench'** refers to the members duly invited by the institute, to adjudge anyof the rounds, collectively.
2. **'Clarifications'** means explanation published by the institute on the mootproblem, at any point of time of the competition or a query posed by any competing team within the given deadline.
3. **'Competition'** means the '1st CCI- Symbiosis Law School, National Moot Court Competition 2023 on Anti-Trust Laws.
4. **'Governing Council'** means the student-faculty-staff body appointed for the administration and smooth conduct of the competition, including all other members conferred with powers on ad-hoc basis by the 'Ex-officio Chairperson' or 'Faculty In- charge' of the Moot Court Association of Symbiosis Law School, Nagpur.
5. **'Institution'** means and includes 'Symbiosis Law School, Nagpur', a constituent of Symbiosis International (Deemed University) Pune.
6. **'Memorial Round'** refers to the assessment of memorials, submitted by teams, on the predefined criterion, hereinafter mentioned in these rules.
7. **'Moot Problem'** means a set of facts published by the institution for competition.



8. **‘Oral Round’** refers to the oral pleadings made by the teams before the bench during any of the rounds of assessment, including time given for rebuttal.
9. **‘Researchers’ Test’** refers to the test in the form of MCQs taken to determine the Best Researcher in the competition.
10. **‘Team Code’** means a unique code assigned by the institution to the applied and registered team.
11. **‘Team’** means and includes only bona fide representatives of any University, may that be State or Central or any other department recognized/authorized by the Bar Council of India to impart law degrees, and who have applied and registered for the competition by complying with the procedure prescribed in these present rules.

In these rules, unless otherwise stated, a reference to a rule is reference to that rule in ‘NMCC Rules, 2023’.

3. Interpretation:

The Governing Council reserves the right to interpret the rules as it deems fit in order to ensure fairness and equality in the competition. Any such interpretation shall be conclusive and the decision of the Governing Council for the application of the rules shall be final and binding.

The Governing Council may also amend, modify, change or repeal any rule from ‘NMCC Rules, 2023’; the same shall be communicated to the teams in due time. In case of any conflict, the decision of the Governing Council shall be final and binding.

CHAPTER II

1. Eligibility:

- a. Students duly enrolled and pursuing full time 5 years or 3 years' undergraduate law course may apply to participate in the given 'Competition'.
- b. Students enrolled and pursuing post-graduate diploma or short-term certificate courses in law are **not eligible to apply**.
- c. Students from any University/Department/Institute not recognized by the Bar Council of India, to impart law degrees are not eligible to apply.

2. Team Composition:

- a. A team may consist of either two (2) or three (3) members.
- b. A team of two members shall include two speakers only and one of them shall act as a researcher for the purposes of Researcher's Test.
- c. A team of three members shall include two speakers and one researcher.
- d. All members of a team should belong to the same institution.
- e. Any team, intending to change the team composition of the team shall intimate the Governing Council by sending an e-mail at mca@slnagpur.edu.in
- f. Any person, other than the registered team members, is not eligible to avail facilities reserved for the student participants.

3. Registration:

a. General:

1. Each team shall provisionally register for the 'Competition' by filling the provisional registration form which is available at the end of this document as 'ANNEXURE-I', and mailing a scanned copy of the same latest by 7th March, 2023 at mca@slnagpur.edu.in.
2. Provisional registration after the given deadline shall not be accepted, under any circumstances.
3. On receipt of the duly filled provisional registration form, the institute shall respond to the participating team, acknowledging the receipt.

4. After the deadline for the provisional registration expires, the Governing Council shall respond to each provisionally registered team, as specified under clause 3.a.1, with a unique team code, which shall be used to identify the teams during the competition.
5. On completion of the aforementioned registration process, any team may withdraw from the competition by duly filling the withdrawal form attached as 'ANNEXURE-II' at the end of this document on or before 10th March, 2023.

b. Registration Fee:

1. The registration fee for the competition is Rs.5000 per team. (In words-Rupees Five Thousand per team inclusive of 18% GST).
2. The registration fee is to be paid only by the teams that are selected for the Oral Rounds.

c. Payment of Registration Fee:

1. The registration fee for the 'Competition' is to be paid through a wire transfer only.
2. The required details for the same are contained in ANNEXURE-III. No other payment method shall be accepted.
3. The deadline for payment of the registration fee is 15th March, 2023.
4. Any additional charges incurred by the team while making the wire transfer are to be borne by the team.
5. All teams must attach a screenshot/scanned copy of the receipt generated on payment of the registration fee to the form as specified under.

d. Completion of Registration Process:

1. Only selected teams as per Chapter III shall fill in the final registration form along with the receipt generated after the completion of the wire transfer of the registration fee.

2. The scanned copies of the aforementioned documents must be attached to the registration form and submitted within the deadline of payment of registration fee i.e., on or before 15th March, 2023. Registration to the 'Competition' shall be deemed to be confirmed only on completion of all the formalities as specified under (3) Registration Clause, failure to do so, may be treated as withdrawal from the competition and no claim of what so ever nature shall be entertained.
3. **Selected Teams are to also send a scanned copy of their Travel Plans** by duly filling out the form attached as **ANNEXURE-I** to this booklet by 15th March 2023.
4. Teams are also to attach a copy of each individual team member's vaccination certificate to the provisional registration form.
5. On completion of the registration process, any team may withdraw from the competition by duly filling the **withdrawal form** attached as **ANNEXURE-II** at the end of this document.
6. No refund shall be given under any circumstance in case of such withdrawal.

4. Clarifications:

1. Clarifications can be sought on any part of the moot proposition and must be clear. These clarifications are to be sent via e-mail at mca@slnagpur.edu.in.
2. It is at the discretion of the Governing Council to decide whether a clarification sought for is valid and is to be clarified.
3. No mails seeking clarifications will be entertained after 1st March 2023.

5. Anonymity of Teams:

1. Teams shall not reveal their identity in any form during the Competition, except by the means of their Team Code allotted by the Governing Council.

2. Teams must not reveal the name of their institution or names of the participants, anywhere in the memorials or in the course of the oral arguments.
3. Teams must also not make use of or display in any manner whatsoever any logo, pins, badges etc. Any material presented to the Panel should be devoid of any identification mark(s)/seal(s) of the Team.
4. Any violation of Rules 1-3 as mentioned above shall attract severe penalty or disqualification as determined by the Governing Council.
5. The decision of the Governing Council in this regard shall be final and binding; not subject to challenge. While submitting the memorial, the e-mail should have no reference to the name of the institution and should only contain the team code.



CHAPTER III

1. Memorials and Memorial Round:

a. General:

1. Each team shall research into the domain of moot problem and subject to Rules 1-5, Chapter III prepare memorial from both sides, namely, Petitioner/Appellant and respondent.
2. The memorial scores will contribute to decide the selection of the teams for the Oral Rounds.

b. Format of Memorial:

1. The memorials are to be submitted in the format prescribed under Rules 1.b.1- 1.b.5., Chapter III. If a team fails to comply with the given format, it may be penalized in the form of deductions from the memorial marks.
2. The memorials shall contain all of, and only, the following heads, namely-
 - a) Cover Page (It shall include the team code of the team on upper right- hand corner, name of the case, parties for whom written submissions are made, name of the forum approached for dispute resolution and year. Cover page of the memorial on behalf of petitioner/appellant shall be in Blue, and respondent shall be in Red.)
 - b) Table of Contents
 - c) List of Abbreviations
 - d) Index of Authorities
 - e) Statement of Jurisdiction
 - f) Statement of Facts
 - g) Issues Raised
 - h) Summary of Arguments
 - i) Arguments Advanced
 - j) Prayer

3. The memorial shall not contain more than 25 pages (excluding cover page, table of content and index).
4. **FORMATTING AND CITATIONS:** All teams shall give footnotes by adhering to Blue Book: A Uniform System of Citations (20th Edition).
5. **PLAGIARISM:** The governing council reserves the right to disqualify a team, at any stage of the competition, if the memorial or any other part thereof, if found to be plagiarized.

2. Submission of Memorial:

1. Each provisionally registered team shall submit one soft copy of the memorials in PDF Format at memorials@slnagpur.edu.in by 10th March 2023.
2. Teams which are subsequently selected for the oral rounds shall bring with them **8 hard copies** of each side of memorials for the Oral rounds all of which shall be submitted to the Organizing Committee at the time of On-Campus Registration.
3. Participating teams may also bring any number of extra copies of the memorials to be used during the competition for their own reference if they wish to do so.
4. The institute shall not be liable to provide the teams with any type of assistance regarding the copies of memorials to be submitted.
5. Submissions made after the specified deadline may lead to penalties in the form of deductions from the memorial marks.

6. Assessment of Memorials:

The memorials shall be assessed out of 100 marks, by a team of experts on the predetermined criterion, as specified here under:

- a. Clarity of Facts. (10 Marks)
- b. Use of Law. (25 Marks)
- c. Use of Authority/Precedents. (20 Marks)
- d. Arguments and Clarity of Thought. (25 Marks)
- e. Presentation. (10 Marks)
- f. Originality. (10 Marks)

7. Memorial Round:

1. A total of 20 teams out of the registered teams shall be selected for the Oral Rounds purely based on the marks obtained by the team in the Memorial Round.
2. Result of the Memorial Round shall be final and non-reviewable on any grounds.
3. The Governing Council shall communicate the result of the Memorial Round to each team.
4. The result so published shall include a list of 20 selected teams and a waiting list of 5 additional teams.
5. The teams in the waiting list shall be allowed to participate only in the occasion of withdrawal of a selected team from the competition. Such information shall be brought to the notice of the wait-listed team by the Governing Council in due time.

6. Rights over Memorials:

The administrating authority of the competition reserves the rights to disseminate and produce the memorials as and when deemed necessary for the purpose of the competition. Submission of the memorials will constitute the team's consent to do the same. The governing council will not take any responsibility for the mistakes found in the final submission of the memorial.



CHAPTER IV

1. Dress Code:

- a. The participants shall adhere to the following dress code while in the courtrooms:

Women- White salwar and kurta or white shirt and black trousers or skirt along with a black blazer and black shoes.

Men- White shirt, black trousers, a black tie, a black blazer and black shoes.

2. Structure of the Competition:

a. General:

1. The competition will be held for three days, 31st March, 2023 – 2nd April, 2023. Information relating to Draw of Lots will be communicated at a later stage.
2. The competition shall consist of Researcher's Test, Preliminary Rounds, Quarter Final Round, Semi-Final Round and the Final Round.

b. Researcher's Test:

1. Researchers from every team qualifying for the Oral Rounds shall participate in the researcher's test.
2. In case of a Two-member team one of the Speakers shall act as the researcher for the purposes of this exercise.
3. The Pattern of the Researchers Test shall be Objective Pattern Paper conducted in an offline mode during the course of the event.
4. The duration of the test shall be that of 30 minutes consisting of 30 Multiple Choice Questions.
5. **2 marks** will be awarded for every correct answer.
6. There will be a deduction of **1 mark** for every wrong answer.
7. No marks will be awarded or deducted for an unanswered question.
8. The schedule for the same will be shared with the participating teams well in advance.

c. Preliminary Round:

1. A total of Twenty (20) Teams shall participate in the preliminary rounds.
2. The rounds shall be conducted physically in various courtrooms **in two phases**, Preliminary Round I-A and Preliminary Round I-B.
3. Each Team shall argue **once from each side** allotted to them through Draw of Lots which shall be notified to the teams shortly after the Inauguration Ceremony. The Memorials of opposing teams will be made available to both the teams and judges before the rounds accordingly.
4. In both the rounds, each team will be given **20 minutes** to present their oral pleadings and an **additional 5 minutes** shall be given for Rebuttal and Sur-rebuttal each.
5. The speakers shall have the liberty to divide the time between them as they see fit. However, each Speaker shall have to speak for a Minimum of Five (5) minutes.
6. At the beginning of the preliminary rounds, the teams shall specify the time distribution for their rebuttals of each team to the Court Room Master. The rebuttal round shall be initiated once the Court Room Master informs the team about the commencement of the time limit.
7. The commencement of sur-rebuttal round shall be informed to the teams by the Court Room Master and the procedure will be same as that of the rebuttal round. (As specified under rule 6).
8. The final score awarded to participating teams shall be a combination of both the score awarded in Oral Rounds and the Scores awarded during Memorial Evaluation. (70% Oral Rounds+30% Memorial Rounds).
9. Top 8 Teams shall qualify for the Quarter-Final Rounds on the basis of abovementioned scores.
10. A team which has won both the Preliminary Rounds shall be given a preference for qualification over a team which has higher final score.
11. In case of a tie between two teams, Memorial Round Scores shall be considered.

d. Quarter-Final Rounds:

1. Top 8 teams from the Preliminary Rounds shall qualify for the Quarter-Final Rounds.
The Quarter-Final Rounds shall be Knock-Out Rounds.
2. Winning teams from each court room shall qualify for the Semi-Final Rounds. Only Oral Rounds Scores shall be considered for evaluation.
3. In case of a Tie in the scores calculated, the team with the higher score in the Memorials (Written Submission) shall proceed to the Semi-Final Rounds.
4. Each team will get a minimum of 30 minutes to argue from the allotted side, including 5 minutes' time that shall be reserved for Rebuttal and Sur-rebuttal each.
5. The speakers shall have the liberty to divide the time between them as they see. However, each speaker shall have to speak for a Minimum of Five (5) minutes.
6. Rebuttals shall only be permitted to the Petitioner/Appellant and in no circumstance whatsoever, shall the Respondent be allowed to spare any separate time for Sur-rebuttal.

d. Semi-Final Rounds:

1. The top four teams from the Quarter Final Round shall qualify for the Semi-Final round.
2. A Draw of Lots shall be conducted to determine the pleading side for the Semi-Final Rounds.
3. Each team will get a minimum of 40 minutes to argue, with an additional 5 minutes for Rebuttal and Sur-rebuttal each.
4. The speakers shall have the liberty to divide the time between them as they see fit. However, each Speaker shall have to speak for a Minimum of Fifteen (15) minutes.
5. Rebuttals shall only be permitted to the Petitioner/Appellant for (5) minutes and the opportunity of the Sur-rebuttals shall be granted to the Respondent only at the discretion of the Judge.
6. A time-extension for a maximum of 2 minutes may be granted to each team at the discretion of the Judge.

e. Final Rounds:

1. The top two teams from the Semi Final Round shall qualify for the Final round.
2. A Draw of Lots shall be conducted to determine the pleading side for the Final Rounds.
3. Each team will get a minimum of 45 minutes to argue, with an additional 5 minutes for Rebuttal and Sur-rebuttal each.
4. The speakers shall have the liberty to divide the time between them as they see fit. However, each Speaker shall have to speak for a Minimum of Eighteen (18) minutes.
5. Rebuttals shall only be permitted to the Petitioner/Appellant for (5) minutes and the opportunity for Sur-rebuttals shall be given to the Respondents only at the discretion of the Judge.
6. A time-extension for a maximum of 2 minutes may be granted to each team at the discretion of the Judge.

3. Assessment Criterion for Oral Pleadings:

Team performance of the orators shall be judged in all rounds on the basis of following criterion-

- a. Knowledge of Facts. (20 Marks)
- b. Application of Laws to Facts and Interpretation. (20 Marks)
- c. Argumentative Skills. (20 Marks)
- d. Clarity of Thought and Expression. (20 Marks)
- e. Court Mannerisms. (10 Marks).
- f. Response to Questions. (10 Marks).

4. Rules for Qualification:

1. The preliminary round shall be decided on the basis of allocation of a total of 100 marks; which includes 30 percent of the marks of memorial round and 70 percent of the marks of oral pleadings. Top 8 teams shall qualify from the preliminary rounds to the Quarter Final Rounds on the basis of the same.
2. The Quarter Final Rounds shall also be Knock-Out Rounds. Average marks obtained out of 100 in the oral pleadings will be the only decisive factor for determining which team will qualify for the Semi-Final Round. In case of a tie in the oral pleading marks, the memorial marks will determine the qualifying team. Even then if the tie persists, the team with the highest individual score will qualify for the Semi-Final Round. Four Teams shall proceed to the Semi-Final Rounds.
3. The Semi-Final Round shall also be Knock-Out Rounds. In the Semi-Final Round average marks obtained in the oral pleadings out of 100 will be the only decisive factor in determining which team has qualified for the Final Round. In case of a tie in the oral pleading marks, the marks obtained in the memorial round will determine the qualifying team. Even then if a tie persists, the team with the highest individual score will be qualified for the Final Rounds.
4. In the Final Round average marks obtained in the oral pleadings out of 100 will be the only decisive factor in determining the team that has won the competition. In case of a tie in the oral pleading marks, the marks obtained in the memorial round will determine the winner. Even then if a tie persists, the team with the highest individual score will be declared as the winner of the competition.

5. Prizes and Awards:

1. The winner of the Final Round shall be declared as the “Winner” of the competition and shall be awarded a certificate of merit.
2. The other team that made it to the Final Round shall be declared “Runners up” and shall be awarded a certificate of merit.
3. Best Speaker shall be determined on the basis of the highest average marks obtained in the preliminary round, and shall be awarded a certificate of merit.
4. Best Memorial shall be determined on the basis of the highest marks obtained in the memorial round, and shall be awarded a certificate of merit.
5. The Highest scoring participant from the Researchers Test shall be declared as the 'best researcher' and shall be awarded a certificate of merit. Every participating team shall be awarded a 'Certificate of Participation'.
6. No 'Certificate of Participation' shall be granted to those teams who have not qualified the memorial round. Prizes given by sponsors, if any, shall be additional to what has been mentioned.



CHAPTER V

Miscellaneous Provisions:

1. No team shall indulge themselves in any act of misconduct inside or outside of the court room, undermining the credibility of judges or that of the competition. If done, it may lead to immediate disqualification.
2. Any behavior of indiscipline with the Governing Council or any other staff member or student volunteer shall be dealt with strictly.
3. Feedback for the participants if any shall be shared by the judges at their own discretion and teams are not allowed to contact the judges in reference of the same.
4. Any attempt to approach the framer of the moot problem or judges of the competition, prior to the competition shall be met with strict consequences.
5. It is suggested to the teams to bring their case compendium with them when they are coming for the oral rounds.
6. No electronic devices will be allowed to be used in the court rooms during the court proceedings.

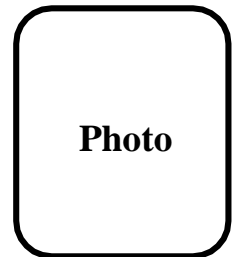

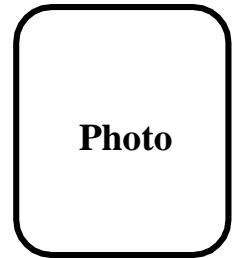

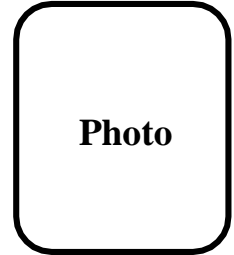
