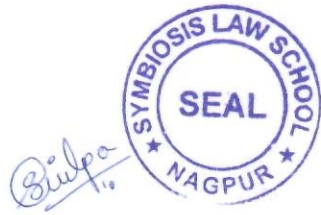




Adv. Pitambar Yadav addressing the students and screenshot of more than 100 students participating in the session.
