The Placement Cell of Symbiosis Law School, Nagpur organized a Webinar on the topic "Laws on Economic Offences in India" on 19th February 2022 at 4:00 PM. The distinguished speaker for the webinar was Senior Advocate Vikas Pahwa, Supreme Court of India. The webinar commenced with the Welcome address by Dr. Sukhvinder Singh Dari, Director, Symbiosis Law School, Nagpur who welcomed the honorable Guest speaker and the enthusiastic participants.

Senior Advocate Vikas Pahwa addressed the students by explaining about Economic Offenses and how they have large ramification on the economy of India & hence they are also called as Socio-Economic Offenses. He briefed the students about the entire trial process for Economic offense & the Special Acts introduced like 'Black Money Act 2018', and recently introduced 'Fugitive Economic Offenders Act' which has a comprehensive procedure.

Adv. Vikas Pahwa explored the Company Act & the Money Laundering Act & the briefed about the various amendments done in the Act. He explained as due to the large ramification on the economy, now there are separate dedicated courts to deal White Collar Crimes. He also brought to notice the latest prevailing scams in the country.

During the session Adv. Vikas Pahwa discussed the various nuances of Economic Offenses, Criminal Law, Cheating, Forgery, Criminal breach of Trust, Vicarious Liability & various provision of Bail. He explained the intricate difference between offenses like Cheating & forgery & also sighted with examples of real estate business for students to have a better understanding.

The webinar was followed by a Question Answer session, Adv. Vikas Pahwa patiently answered to all the questions which were being asked by the inquisitive minds.
