Submission Guidelines

(1) The entry and the blog write-up should be strictly in the prescribed format as mentioned herein.

(2) Every entry should have a title along with other essential information about the participants: -

- Name of the participants
- Name of the institute
- Semester
- Programme

(3) The write-ups must be in consonance with the theme for the month.

(4) Multiple entries by a participant are not allowed. If done then it shall lead to the disqualification of the same.

(5) Writers can submit their entry along with their write-ups as per the deadline mentioned in the flyer for that month.

(6) The write-ups should be strictly in English language.

(7) Plagiarism can be considered only up to 10%

(8) The formatting guidelines for the write-up is as follows:-

·Font : Times New Roman

·Font size : 12

·Alignment : Justified

·Line Spacing : 1.5

·Word Limit : 750-1000 words

·Prescribed format. : Word format only (.doc or .docx)

(9) Co-authorship is not permissible

(10) The selection and evaluation criteria would be at the discretion of the cell.

(11)The entries of those participants who do not adhere to the above -mentioned rules and guidelines will not be considered.
