FRESHER'S MEMORIAL DRAFTING COMPETITION - 2023

Symbiosis Law School, Nagpur conducted the Fresher's Memorial Drafting Competition – 2023 on 6th October, 2023. The competition was open for the fresher batch of 2023-28 at Symbiosis Law School, Nagpur. The Proposition for the competition was based on the Law of Contracts. The participants were given the liberty to form a team comprising of two members and were given one month for preparing their respective written submissions. Participants were supposed to submit written submissions from both the sides, i.e., plaintiff and defendant. The judging criterion for teams was based on their written memorial submissions.

The Competition saw the participation of 27 teams from the first-year batch. Before the commencement of the competition, a workshop was conducted for the participants, to give them an opportunity to get insight into the intricacies and learn about memorial drafting. The primary objective of the competition was to improve the writing, research and analytical skills of the students and the purpose was to give the participants an experience of simulation to test and further enhance their research and drafting skills. The competition reached its feat of refining the crucial qualities that are needed in the legal field like researching, drafting and critical analysis of a legal problem.

After receiving the written submissions from the participants and reviewing of the submissions, the Moot Court Association of Symbiosis Law School, Nagpur released a merit list on the basis of the markings awarded by the adjudicators. **Team no. 18** comprising of Mr. Atharva Kapse and Joel Johnson was declared winner of the competition, while **Team no. 19** comprising of Krishna Futane and Aditya Mendhekar and **Team no. 29** comprising of Ram Sharan Reddy Kontham and Nyapathy Raghotham backed the second and third place respectively.

The competition was an immense success and received overwhelming response and positive feedbacks. Symbiosis Law School, Nagpur aspires to conduct similar events in the future.





