### **Guest Lecture on "Journey from Lawyer to Judge" at SLS, Nagpur.**

He emphasized the need for having robust, dynamic young lawyers to defend constitutional values. The address was motivating for the students. After the session, Lordship had informal interaction with students and answer their queries.

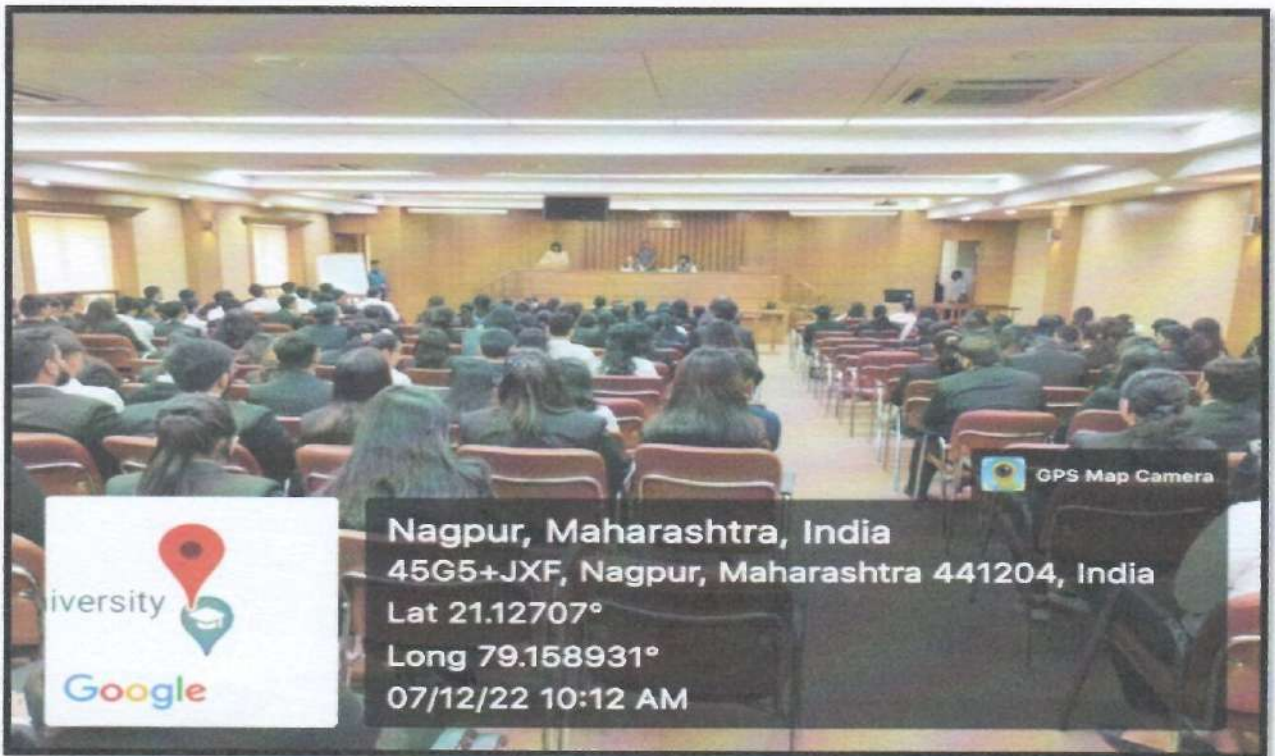

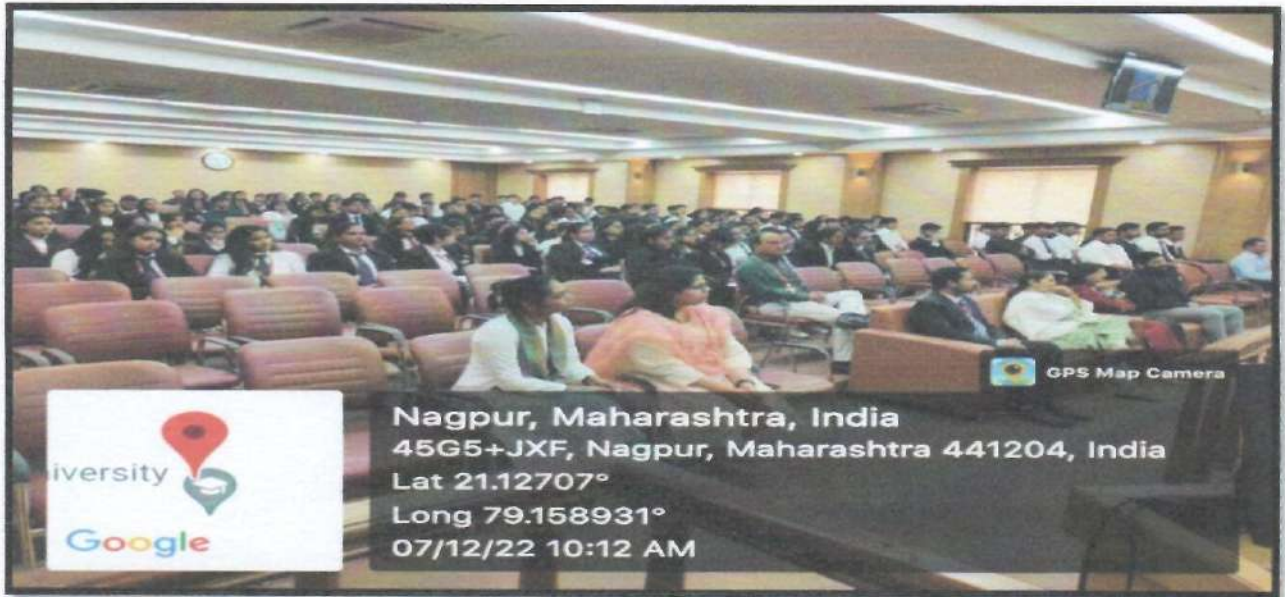


