Induction of the Student Council, SLS Nagpur (2022-23)

Keeping in mind the tradition of SIU to have a student representation towards the attainment of our goals and with an objective of holistic development of our students, Symbiosis Law School Nagpur initiated the process of inducing the Student Council for the academic year 2022-23. This was done with an aim that the Student Council will strive to assist the institute in its development and also to impart leadership qualities to the students so that they can play their part in nation-building.

The process was divided into two parts; firstly, the interested students were asked to submit their candidature for the required posts along with the Statement of Purpose through a google form circulated for this purpose. In second round the students were required to appear before the panel of external members and on the basis of the combined scores of both the parts the highest scorers were appointed on the concerned posts.

There were more than 150 applications received for the same and 5 different panels were formed consisting of the external members. The students were allowed only to apply for the two posts and the post of President was reserved only for the students of the penultimate year. The process was conducted by the Faculty In-charge of the Student Council, Mr. Ahmar Afaq under the guidance of Dr. Sukhvinder Singh Dari, Director SLS Nagpur. The students showed great enthusiasm in the whole process. The Council will serve as the voice for an entire student body and actively works with teachers and advisors to promote a better learning environment.


