Taking forward its legacy of Internationalization Symbiosis Law School, Nagpur organized a Guest Lecture of Mr. Sajid Sheikh, a senior legal practitioner as well as he is also currently serving as a Managing Director at Sentinel Solicitors, London, United Kingdom on the topic "Mastering Skills for Successful Advocacy" on 30 January 2024 as a part of the SLS Nagpur's International Lecture Series initiative.

Mr. Sheikh is a resolute believer in the protection of Human Rights and Equal Opportunities, which are evident, both in the success of his legal cases and in the manner in which the firm is managed. He has been specializing and committed to Immigration and Asylum Law since 1992. His compassion and dedication are apparent in his extensive involvement and high profile within his field. He was a member and senior assessor of the Law Society's Immigration Panel, a consultant on the Legal Services Commission Peer Review Committee and a committee member of the Legal Aid Practitioners Group. He has appeared on several TV Channels as an Immigration Expert.

Mr. Ahmar Afaq, Faculty head of the International Cell, SLS Nagpur welcomed the Guest and thanked Mr. Sajid Sheikh for considering our invitation and agreeing to deliver a lecture. 
Mr. Sajid Sheikh started with an introduction to his journey and the challenges in his career. He talked about his experience in the legal setup of India as well as the U.K. and highlighted how students can pursue their careers inside the scope of India or choose to expand their practice abroad. He in detail explained his experience working with refugees, homeless people and immigrants. And Also, mentioned the fact that he has helped over 5,000 such families by fighting for their rights. He went on to describe his expertise in human rights and equal rights laws and how he has utilized this specialization to earn a good name in this field. He shed light on the fact that human rights specialization is seen to be an arena where there is no actual profit, but by giving an example of his own life and his financial success he explained how one can have a desired earning while helping others in need through the scope of law. His session was

found to be inspiring and catered well to the budding hopes of the students who dream of having a similar occupational path.

In his final remarks, he advised the students to seize any opportunities to uplift their careers in the legal field. He spoke about retaining one's originality and creativity to achieve one's set goals. The Workshop proved to be an incredible learning opportunity for Law students of SLS Nagpur with the participation of several attendees

The session was followed by a very exhilarating and captivating Question & Answer session in which he dealt with several questions posed by the students who were present in the lecture. He defined the difference between the limitations and challenges of using Advocacy skills in the current legal landscape. As well as other intriguing questions put forth before him.


The Session proved to be an excellent learning platform for Law students across the country with a participation of more than 100+ attendees.
