Report

Jail Visit organized by Legal Aid Centre

25/3/2023

On 25th March, 2023 students and members from Legal Aid Centre, Symbiosis Law School visited Central Jail, located in Ajni Road, Nagpur. The visit was part of a program organized by the college to provide students with practical exposure to the criminal justice system. The purpose of the jail visit was to give students a better understanding of the functioning of the Jail system, the conditions of imprisonment, and the challenges faced by inmates.

During the visit, the students were given a guided tour of the jail facility. They were shown various parts of the jail, including the cells where the convicted and under trials were detained, the dining area, the exercise yard, and the medical facility. The students also had the opportunity to interact with some of the inmates and ask them questions about their experiences in the jail.

In addition, the students had a meeting with the jail superintendent, who briefed them on the jail's functioning, the policies and procedures followed by the jail, and the challenges faced by the staff in maintaining discipline and ensuring the safety of the inmates.

The students were also shown the vocational training center in the jail, where inmates are taught various skills such as carpentry, tailoring, and computer literacy. The jail also had a library and facility to pursue B.A. course from Indira Gandhi National University and YCMOU. This was aimed at giving students an insight into the efforts being made to help inmates acquire skills that can help them reintegrate into society after their release.

The jail visit was an enriching experience for the students. It provided them with an opportunity to learn about the criminal justice system and the challenges faced by inmates. The visit also helped to sensitize the students to the plight of the inmates and the need for reforms in the criminal justice system.

Overall, the jail visit was a valuable learning experience for the students and an excellent initiative by the college to provide practical exposure to the criminal justice system. Total 40 students from the college participated in the visit.
