REPORT

5TH INTERNAL MOOT COURT COMPETITION-2023

12.08.2023

Symbiosis Law School, Nagpur conducted its Fifth Internal Moot Court Competition on 12th August 2023. The competition was open for participation from all four batches hailing from second, third, fourth and fifth year law students at Symbiosis Law School, Nagpur. The moot proposition was based on Constitutional validity of recently introduced Criminal Procedure (Identification) Act, 2022. The participants were given choice and liberty to form a team consisting of three (3) members the composition of which was 2 speakers and 1 researcher. The participants were given one month for preparation of Written Submissions and Oral Arguments. The judging criteria for the competition was two-fold viz. assessment of Written Submissions and Advocacy skills during oral rounds scheduled on 12.08.2023.

The competition saw an overwhelming response from 149 teams. The competition was adjudged by a panel consisting of distinguished judges which comprised of eminent lawyers and faculty of the college. The judges were impressed by the performances of the teams and further gave remarks and comments on the hard-work, exposition, analytical and oratory skills. The competition was a great learning experience for the participants. It enabled the students to indulge in an authentic simulation of an actual court with an aim to hone their advocacy and drafting skills. The competition reached its feat of refining the crucial qualities that are needed in the legal fields like researching, drafting, and presenting arguments through this endeavor.

After the completion of oral rounds, the Moot Court Association of Symbiosis Law School, Nagpur released a merit list nominating teams on the basis of their absolute ranks. **Team TN-05** comprising of Dheeraj Samanchi, Harsh Pavasiya and Elisha Vattappillil was declared as the Winners of the competition, while **Team TN-62** comprising of Ayesha Aslam, Vishwanshi Gadhabi and Tiasha Perreira and **Team TN-141** comprising of Advait Nisal, Rasika Alur and Arnav Ashtikar backed second and third position respectively. 
