Empowering Lawyering Skills through Police Station Visit

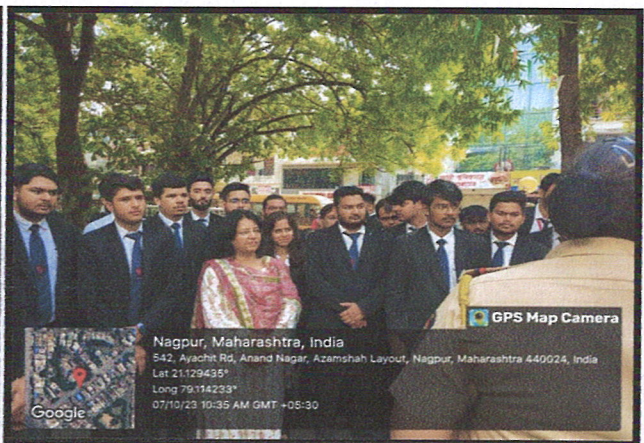
On October 7, 2023, the students of the Legal Aid Centre at Symbiosis Law School, Nagpur visited the Sakkardara local police station as part of their Pro Bono Services under the supervision and guidance of Dr Sukhvinder Singh Dari, Director of SLS Nagpur and Dr. Deepti Khubalkar Faculty In-charge of the Legal Aid Centre. The visit aimed to provide student members with practical insights into the workings of law enforcement and to foster a better understanding of the legal system.

During the visit, the members had the opportunity to interact with police officers and learn about their roles and responsibilities. They observed the various departments within the station, including the records section, the investigation unit, and the cybercell block.

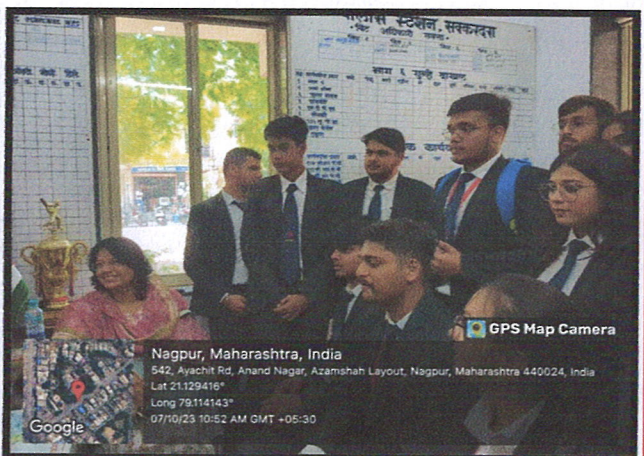
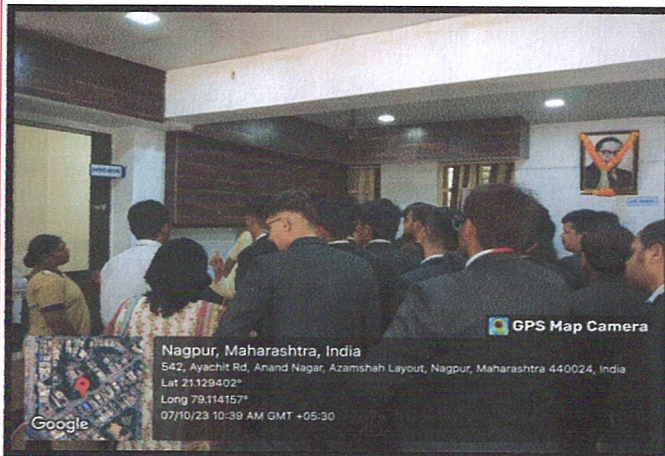
