### **Symbiosis Law School, Nagpur organized Training Session on Banking Laws & Mock Interview for Recruitment**

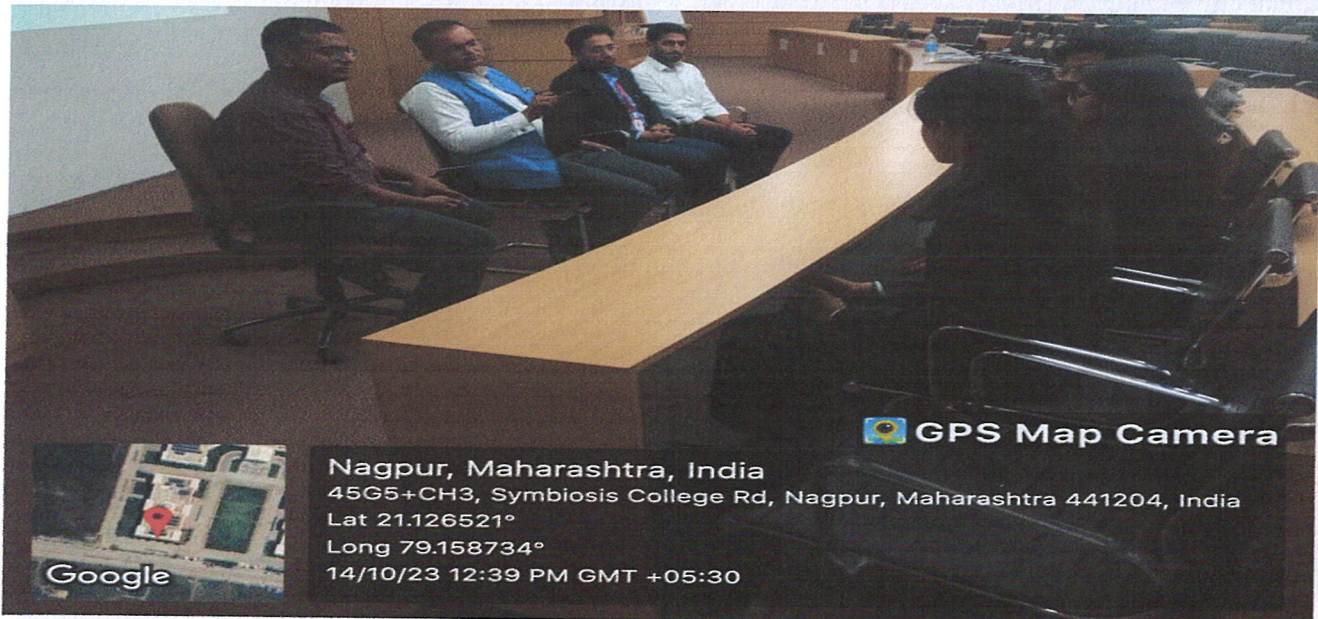


