### **Report on Workshop on 'Dispute Resolution: Law and Practice'**

**Date: 2<sup>nd</sup> & 3<sup>rd</sup> September, 2023**

The Training & Placement Cell of Symbiosis Law School, Nagpur organized a Two-Day Workshop on 'Dispute Resolution: Law and Practice' on September 2 -3, 2023. The Workshop was conducted by Adv. Suadat Ahmad Kirmani, Partner, IndusLaw, Bengaluru. The Workshop commenced with the Introduction & Felicitation of the Hon'ble Guest Speaker.

Adv. Suadat Ahmad Kirmani started the Workshop with a session on Litigation and Mediation in Commercial disputes. He engaged with the participants to the nuances of litigation and the recent Mediation Bill pending assent of the Hon'ble President of India. He also shared his experiences and career paths, offering valuable guidance to the students in aspiring dispute resolution.

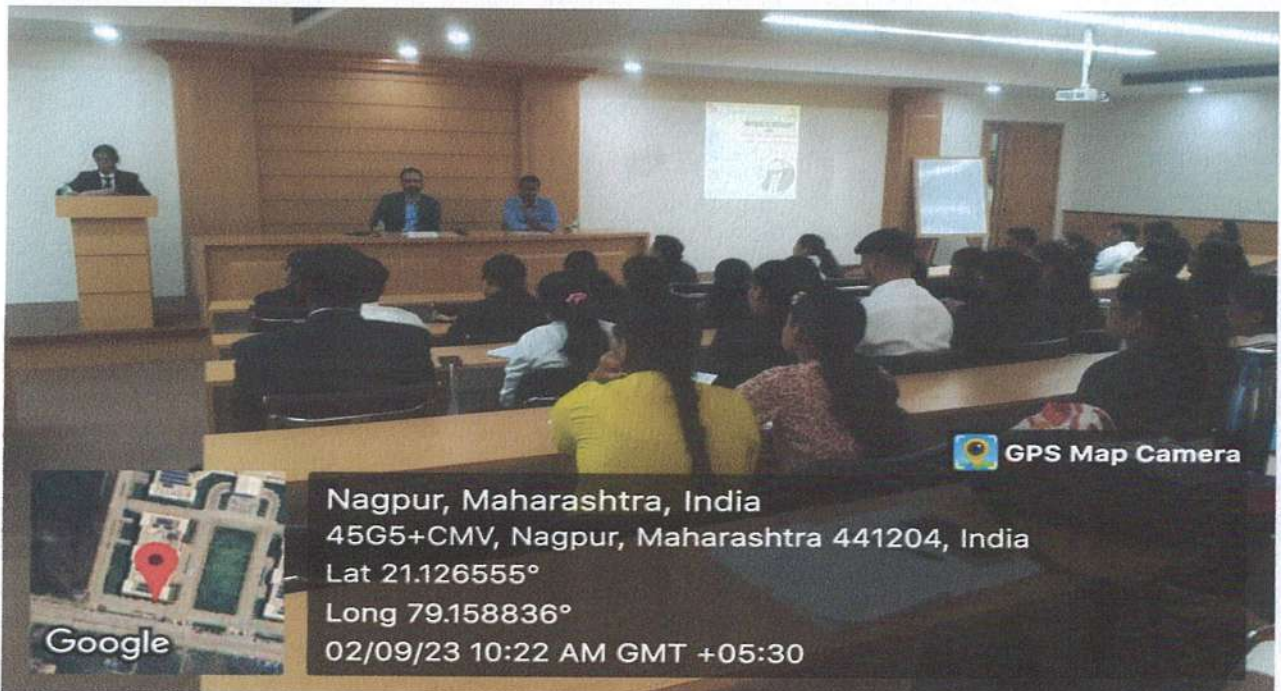

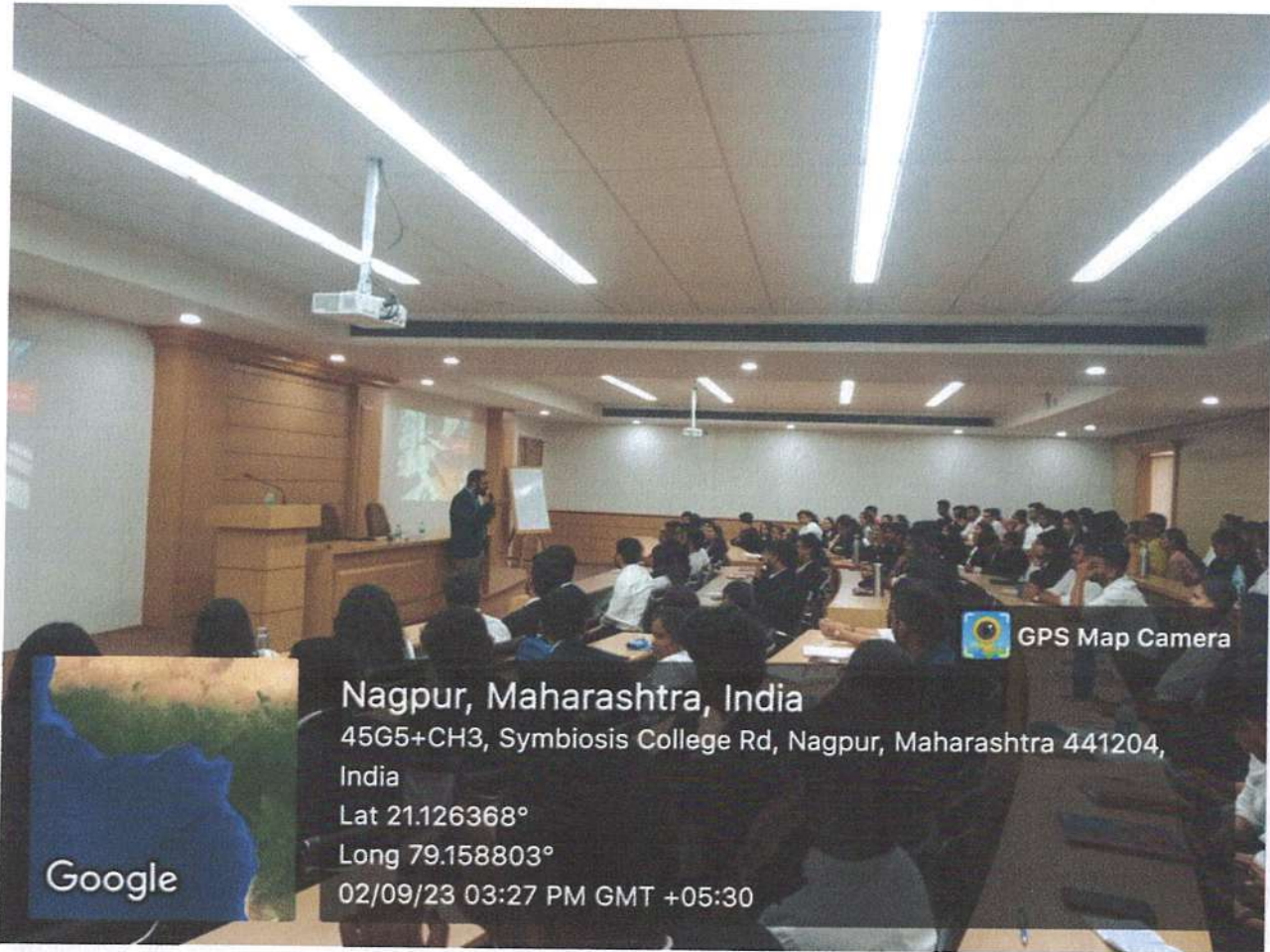
