#### **WORKSHOP ON 'THE ART OF WRITING A RESEARCH PAPER'**

**HELD ON 16<sup>TH</sup> SEPTEMBER 2022**

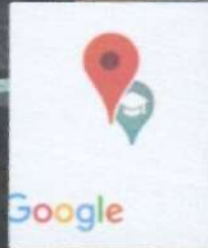
The Research & Publication Cell of Symbiosis Law School, Nagpur organized a One - Day Workshop titled 'The Art of Writing a Research Paper' on the 16<sup>th</sup> of September 2022 for the students of LL.M. The workshop was organized with the objective of giving hands-on training to the students for undertaking legal research. Writing a research paper is a part of the LL.M. curriculum, therefore channelized guidance is necessary for constructive writing. The workshop was divided into two sessions for the day. For this purpose, we invited Dr. Rupal Rautdesai, visiting faculty at Symbiosis Law School, Pune, and Adv. Namit Saxena, Advocate on Record, Supreme Court of India to address the students. The Workshop started with the welcome address by Dr. Sukhvinder Singh Dari, Director, Symbiosis Law School, Nagpur followed by felicitation of the guests.

Dr. Rupal Rautdesai was the resource person for the first session of the day. She addressed the students on '*Basics of Research Methodology*'. Madam dealt with the preliminary requirements to be adhered to while doing research and while writing a research paper. She also informed the students about certain ideas which will be useful for honing their research skills. Madam also explained the basics of Doctrinal Legal Research and Empirical Legal Research. 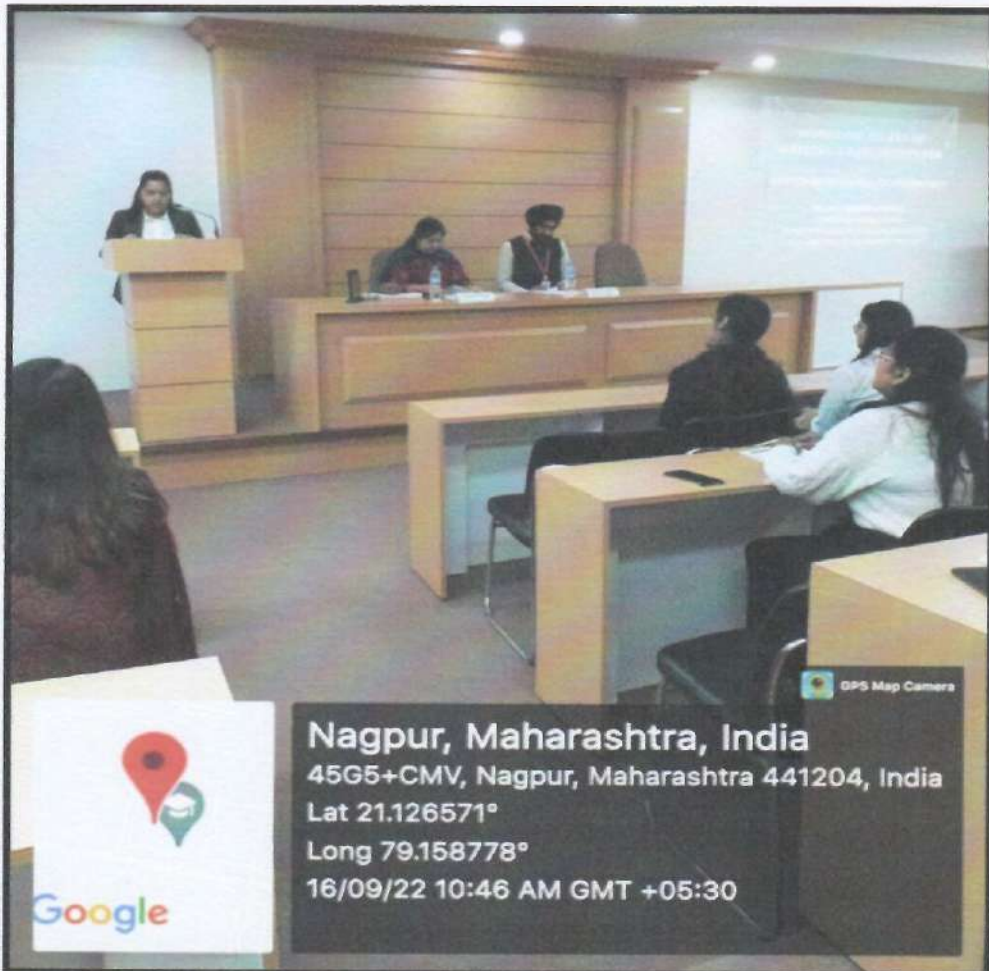
