An Interface on Artificial Intelligence & Law

24th April, 2021

Symbiosis Law school Nagpur organised an Interface on Artificial Intelligence, on 24th April 2021 from 10.00 am onwards. Continuing the tradition of bringing out the best in Students in terms of their holistic development, Dr. Sukhvinder Singh Dari, Director of Symbiosis Law School, Nagpur, in his Welcome Address put emphasis on the importance of artificial intelligence in coming days for legal profession and explained his attachment for participation of students in such activities as an intrinsic part of their all-round training. While addressing, he stressed on the importance of technological development, and as budding lawyers to pace with such advancement is crucial for professional development. He also thanked the participants for attending the workshop.

The Speaker of the session Adv. Jayant Bhatt a Supreme Court Practicing Advocate and an Independent litigator based in New Delhi, India, shared some great examples through his experience of court, while conducting many cases in the trial courts, High Court And Supreme Court related to issues of technology and how artificial intelligence is slowly entering into the terrains of legal dynamics. He introduced the law students to the world of synthetic technology which is going to rule the human existence in a decade or so. After a brief introduction, he step by step helped students to understand that as a budding lawyers, what challenges are awaiting for them in the legal field in context of artificial machinery intelligence. He emphasized that it is only humans who are creating these machines, so ultimately it is that human creator who acted as creator of the machine will be made responsible for any debacle that will be take place on the front of artificial intelligence. He brought to the notice of budding lawyers who are more than hundred and forty in number that there is no starting point for learning new things, AI may not have full blown itself but if

during their learning years they start gathering knowledge about the same there can be a better world that can be weaved around by them when they will actually will be joining the legal profession. All participants appreciated the Session.

National Webinar on "Introduction to Forensic Science

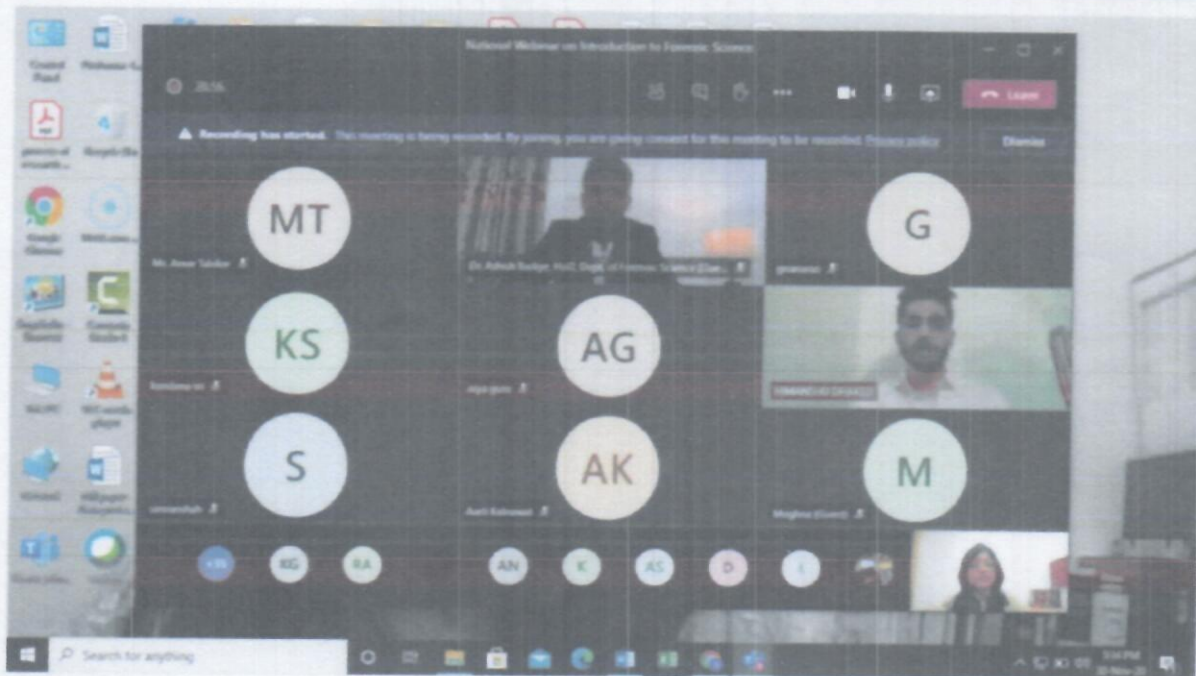
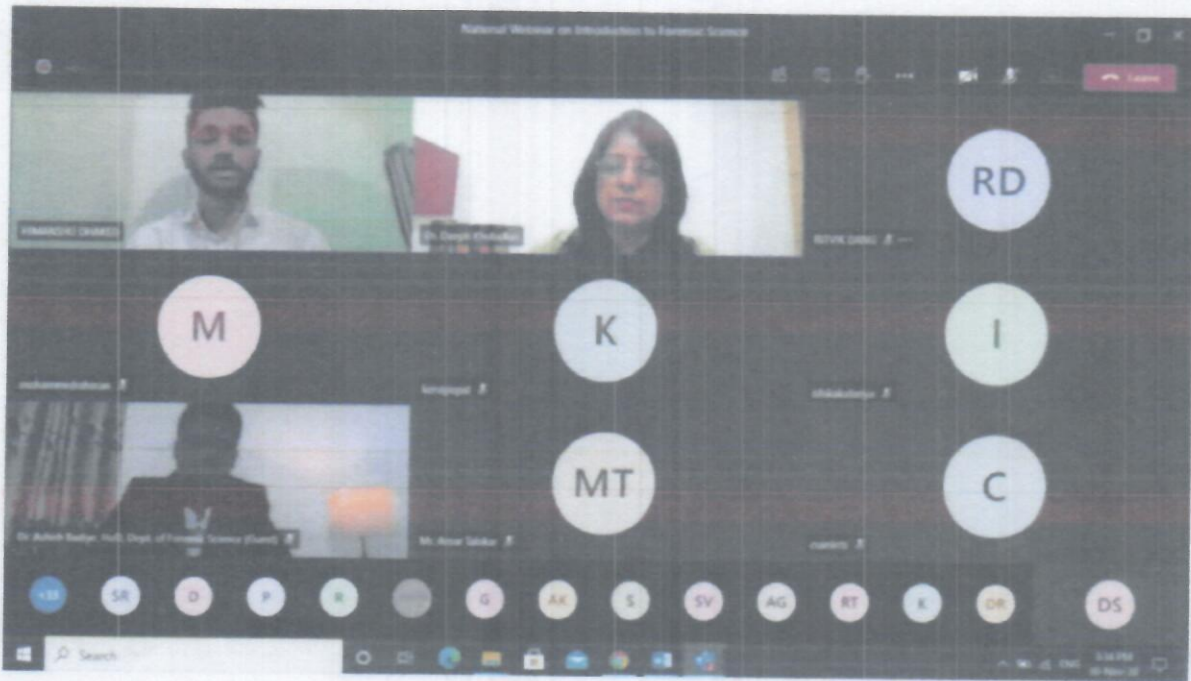

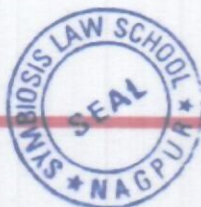

Online Legal Awareness Programme on Emerging Data Protection and Data Privacy Regulations in India in Collaboration with FDPPI

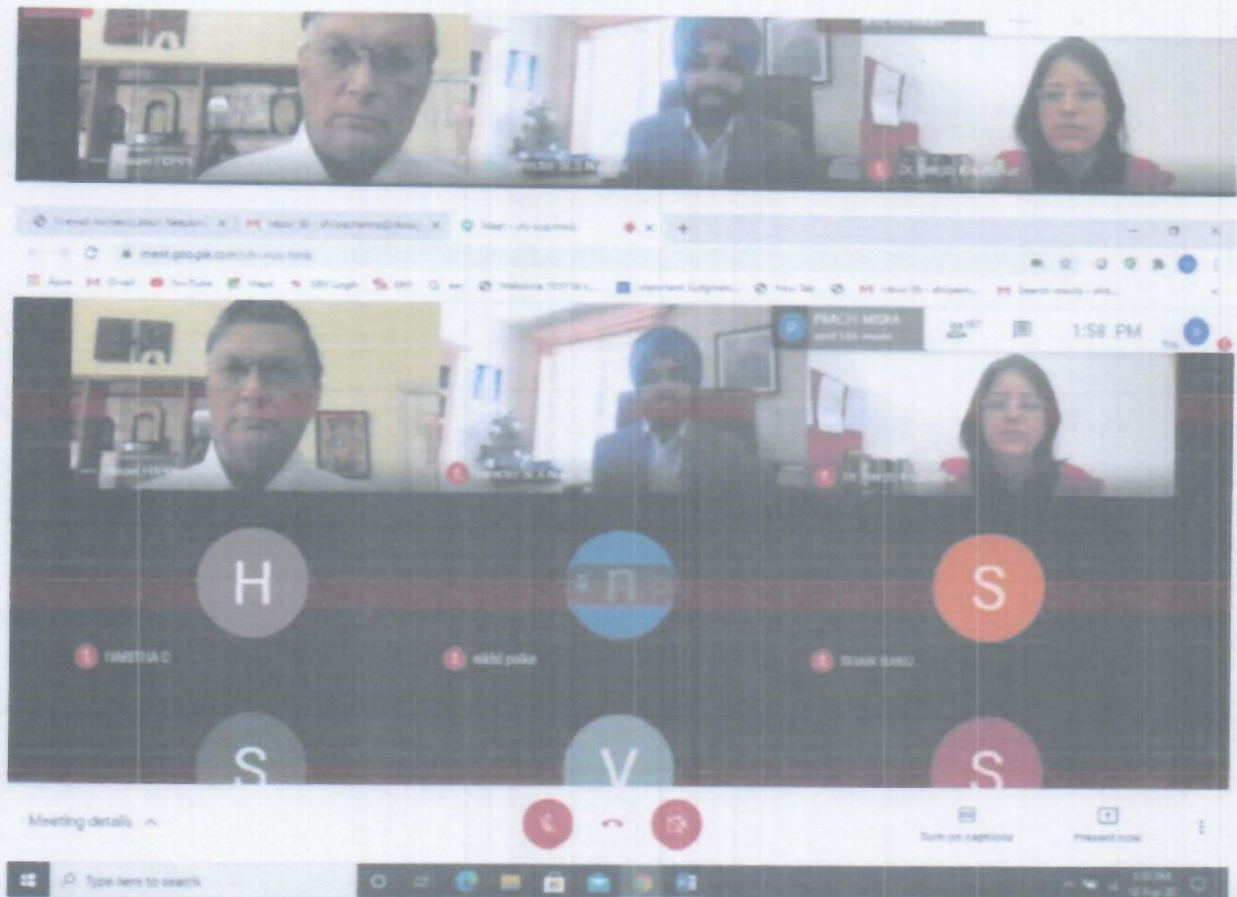
10th September, 2020

Mr. Rao also quoted Justice Chandrachud in defining privacy as a desire of a human being to be left

alone. Mr. Rao gave an in depth analysis of Data Protection Bill Data Protection Authority, rights under the Bill and Section 43A of IT Act, 2000.

The webinar ended with a question and answer session relating to data privacy in cyberspace and related issues. Vote of thanks was proposed by Ms. Ritu R. Jaiswal, Member, Legal Aid Centre and Student, SLS Nagpur.

REPORT OF CAPSULE COURSE ON CYBER LAWS
