

REPORT OF WORKSHOP ON MEMORIAL DRAFTING

27th & 28th September, 2019

On 27th and 28thSeptember, 2019, a Workshop on Memorial Drafting was organized by the Moot Court Association of Symbiosis Law School, Nagpur for the BA/BBA LL.B. students. The venue for the workshop was the Moot Court hall of SLS, Nagpur. The two day workshop was conducted in three sessions, two sessions on the first day and one session on the second day. The timings for the workshop were 10 AM to 4 PM. The resource person for the workshop was Mr. Rangam Sharma. He is a corporate lawyer based in Bengaluru. He is currently working with J. Sagar Associates and his areas of practice include private equity, venture capital, employment and emerging technologies. Mr. Rangam Sharma elaborately discussed the meaning, role and importance of memorial drafting. This practical learning made students understand the entire procedure of memorial drafting in a better way. The workshop concluded with the doubt solving session, where the resource person entertained the queries of inquisitive law students and answered them to their satisfaction.







REPORT ON WORKSHOP ON RESEARCH METHODOLOGY

5th October 2019

- It is a mock court at which law students argue imaginary cases for practice. Proceedings in the Moot Court follow a set pattern of conduct which is similar to the actual courts. From language to attire, students are required to follow set norms and argue the case with zeal and enthusiasm.
- Mooting is not the same as public speaking or debating, although it shares some
 common elements with these activities. It is a specialized application of the art of
 persuasive advocacy. It has been part of the process of training lawyers for
 centuries and plays an important role in legal education.

WHY MOOT COURT?

- Mooting as an activity aims to inculcate and improve the research, presentation
 and line of reasoning into students so as to equip the budding pleaders with all the
 court room etiquettes, research experience and advocacy skills.
- To appraise the students about presenting the case and preparing written submission and arguing a given case from either side before the court is the main purpose of Moot Court Competition.
- The reasoning of the students is screened in the process and they regularly get informed about the areas which require improvement.



LEGAL AID CENTRE OF SYMBIOSIS LAW SCHOOL, NAGPUR

Legal aid is the provision of assistance to people who are unable to afford legal representation and access to the court system. Legal aid is regarded as central in providing access to justice by ensuring equality before the law, the right to counsel and the right to a fair trial. Legal Aid is essential to guaranteeing equal access to justice for all, as provided for by Article 6.3 of the European Convention on Human Rights regarding criminal law cases. Especially for citizens who do not have sufficient financial means, the provision of legal aid to clients by governments will increase the likelihood, within court proceedings, of being assisted by legal professionals for free (or at a lower cost) or of receiving financial aid. Though legal aid aims to create more equity in the sphere of legal practices, aid offered is often limited in its quality or its social impact by economic constraints that dictate who can access these services and where the aforementioned services are geographically located.

Historically Legal Aid has its roots in the right to counsel and the right to a fair trial movement of the 19th-century continental European countries. "Poor man's laws" waived court fees for the poor and provided for the appointment of duty solicitors for those who could not afford to pay for a solicitor. Initially the expectation was that duty solicitors would act on aprobonobasis. In the early 20th century, many European countries had no formal approach to legal aid, and the poor relied on the charity of lawyers. Most countries went on to establish laws that provided for the payment of a moderate fee to duty solicitors. To curb demand, legal aid was restricted to lawyer costs in judicial proceedings requiring a lawyer.

The Legal Aid Centre at Symbiosis Law School, Nagpur is established with 'Aim & Objective' to 'Serve legal aid, through human resource, knowledge resource, & infrastructural resource, to those who need it the most, purely on pro-bono basis'. It's a blend of legal duty (as laid down under Rule 31 of Bar Council of India's Rules of Legal Education, and Rule 11 of Schedule III of the said 'rules') of the Institute with mission of the Symbiosis International University.

The mission statement of the Symbiosis International University says that it is committed towards 'fostering spirit of national development', 'instilling sensitivity amongst the youth towards the community', 'contributing towards knowledge generation and dissemination', and 'promoting ethical and value based learning'. The establishment of the Legal Aid Centre at Symbiosis Law School - Nagpur acknowledges that it is committed towards fulfilling its 'institutional social responsibility'.

The above laid 'objective' will be achieved when those, who have knowledge, including persons from the legal profession, alumni of the Symbiosis International University, and the students, will come forward to share their knowledge, experience, and expertise with those who are in need of legal aid & support.

Participation of members of the Legal Aid Centre in various activities will make them more sensitive towards various legal issues that are being faced by the society people. It will enhance their understanding of their 'moral duties towards the society', which will lead to 'sense of responsibility in nation building'.

With these 'Aims & Objectives', the Legal Aid Centre of Symbiosis Law School, Nagpur will be active in three directions

LEGAL AWARENESS

Target population, as per the kind of activity, will be made more aware of the legal issue that is being taken up by members of the Legal Aid Centre. This awareness will be created through personal interaction, through pamphlets & posters, and through various other similar modes.

LEGAL LITERACY

Target population, as per the kind of activity, will be taught how to draft very basic legal documents, like, 'writing complaint', 'writing application under the R.T.I. Act', 'drafting an affidavit', and similar other documents.

CORE LEGAL AID

The aided person/s, as per requirement of the situation/case, will be given core legal aid, like, 'giving advice as per the legal provisions', 'bringing aided person/s before legal forum/authority', 'presenting case of the aided person/s before legal authority/forum', and similar other activities.

COMPOSITION

- The Legal Aid Centre at Symbiosis Law School Nagpur constitutes of a 'Head' of the Centre, a 'convener', a 'co-convener', and thirteen 'Para-Legal Volunteers'. A senior faculty member is being appointed as 'Head', and students have been appointed as 'Convener', 'Co-Convener' And 'Para-Legal Volunteers'.
- The Centre, with all the required infrastructural facilities, is situated at Ground Floor of campus of the Symbiosis Law School Nagpur; it is open six days a week (Monday to Saturday) from 9 am to 5 pm.

REPORT ON NATIONAL UNITY DAY


31st October, **2019**




Nagpur: With the Nagpur campus of Symbiosis International (deemed university) getting formally inaugurated by state CM Devendra Fadnavis and union minister Nitin Gadkari on Sunday, the institute's founder and chancellor SB Mujumdar said Nagpur had the potential to turn into a global education hub. "Our Pune is called 'Oxford of the East'. I think very soon Nagpur will be called Cambridge of the East" said Mujumdar, while acknowledging that the city's campus was one of the best in their group.

The sprawling campus with construction of approximately 13 lakh square feet and spread over 75 acres, has left many awestruck.

Designed by Hafeez Contractor, the institute resembles buildings from any ivy league university from the west and has the facilities to match. Symbiosis' pro chancellor Vidya Yeravdekar said the Nagpur campus' design was the result of a strong suggestion by Gadkari.

"He told me not to construct the building for Punekars. This is Nagpur, here people like everything to be grand. And that's how this idea unfolded of having a huge and unique campus," said Yeravdekar.

"So many people leave Nagpurfor higher education and I think this will stop now. If Symbiosis has already filled up its quota of admissions, and there are students waiting, then it is obvious that the intake capacity needs to be increased.

"We will provide the infrastructure needed for the university to grow. A metro station will come up close by, a cement road is being constructed that's connecting with the ring road, the Sports Authority of India's institute is coming up next door. Soon the ecosystem will be ready in east Nagpur so that high quality education can be imparted to stu-

dents," said Gadkari.

CM Fadnavis said that Symbiosis was indeed the dream project of Gadkari. "We both worked on this dream and today it has become a reality. Usually people are of the opinion that good institutes will come up in a city only if big ticket investments from industry happen in the vicinity. That's completely wrong. 






Flag hosting by the students of SLS and SIBM. Nagpur

He also mentioned how social media collects users' data without their knowledge. The faculty members and the students of law found the discussion useful and gained much knowledge from this discussion. A REPORT ON BEST PRACTICES

Best Practice no.1

1) Practice Based Learning

SLS, Nagpur strives for providing the best empirical practices to ensure utmost participation of the students thereby honing their professional skills.

KEYWORDS:

1.Role-play — leadership, analytical skills, decision-making, communication skills, far-sightedness, attitude and approach, interpersonal abilities, promptness.

Objectives of the Practice

Role-play activity addresses one of the vital facets of understanding – perspective which is the ability to have and demonstrate critical points of view, and to be able to see things from another person's perspective. What is important in this case is the opportunity for students to acquire some observational skills and to understand and to assimilate the new information. It is essential in providing the opportunity to students to identify, validate and discuss their emotions.

Parliamentary Debate, as its name suggests, is modeled on the Asian style Parliamentary Debate. Intelligent and straightforward definitions of the motions are expected and rewarded which have to be rapid. It also aims at content for analysis of the issue including relevance, evidence to back, strategizing the process, regulating voice modulations, verbal and non-verbal expressions.

The Practice

➤ In Role-play activity it's essential to identify the objective with necessary information, guidelines for participation, time to prepare for perspective to emerge and reflect. Role-play activity involves a team of 5 students representing the plaintiff, defendant, counsel for plaintiff and counsel for defendant and the Judge. The students are given a judgment to prepare their respective roles by interpreting enactments, precedents and

legal maxims with allied laws which sharpen cognitive abilities, thorough research and understanding of law as well as socio-economic awareness.

Role-play promotes:

- a) Critical thinking and increases student's confidence in addressing an issue successfully.
- b) Encourages the student to assume an active role in constructing knowledge and understanding.
- c) Students are challenged to set priorities in managing information related to laws and rules involved and enhance advocacy skills, analytical skills, interpersonal skills etc.
- d) Encourages collaborative learning, which is a widely supported method in knowledge formation.

Role-play has 3 fold activities:

- 1. Analyzing the problem This comprises of introduction of the case, identification of the issues to be addressed while recognizing the areas of complexities of the legal point of consideration thereby posing questions regarding the legal issues.
- Developing arguments This requires the students to collect resources and materials such textbooks, commentaries, societal concerns, precedents, articles, notes, etc. It involves sharing of opinion, perspectives thereby refining and shaping their mindset.
- 3. Findings and reasoning this enhances cognitive skills, weaves a thought process and helps to arrive at a conclusion.

Best Practice no.2

2) Parliamentary Debate –

Keywords:

Rational thinking, opinionated,

In a Parliamentary debate, a team is called either Proposition or Opposition depending on the side it is given. Both sides are comprised of two debaters who are modeled members of the House. In the same way as the Parliament, the Proposition supports the motion while the Opposition opposes it. Adjudicators also participate and they act as a Judge. Debaters of each side try to persuade judges to vote for their side within a limited period of time.

The Debaters speak in the following order:

■ First Proposition (Prime Minister) Speech 7 minutes

■ First Opposition (Leader of the Opposition) Speech 7 minutes

■ Second Proposition (Deputy Prime Minister) Speech 7 minutes

■ Speech 7 minutes

■ Opposition Reply Speech 4 minutes

■ Proposition Reply Speech 4 minutes

It is the duty of the First Proposition Speaker to define the motion, which describes exactly what the basis for the debate will be. The definition must be fair to the Opposition and provides them an equal case to argue. The Opposition should accept any definition by the Proposition unless it presents an unreasonable or clearly irrelevant interpretation of the motion, or is true and does not leave the Opposition a side to argue.

Evidence of Success

Role-play activities have displayed a good success ratio. The students have been participative and impulsive in the activities. They also introduced certain innovate thinking coupled with detailed research which was expected. Students demonstrated their communication skills confidently enhancing their advocacy skills and interactive proficiency.

Certain students faced difficulties with respect to creative thinking and in articulating their thoughts because lack of awareness or confidence which restricts them to exhibit their complete potential despite having logical reasoning. Thus, students who refuse to participate may serve as observers and share their thoughts and perspectives at the end.

Thus, it indicates that role-play activities help to achieve the aim of enhancing communication abilities to a major extent.

Parliamentary Debates are massive success since it gives an opportunity to the students to express their opinion without strict limitations. The students have scored well displaying keen interest

in this competition. This event is lively and audience-oriented. It aims at intellectual and ethical development by challenging the students to make defensible judgments thereby critically investigating the complex issues evaluating the data. It also lays emphasis on voice their suggestions extemporaneously It was challenging for students with lack of oratory skills, fluency and promptness.

This activity was a good initiative where students were enthusiastic about participation and expressing their opinions.

Problem Encountered and Resources Required

The resources required to implement the practice are judgments, technical help such as projector, desktop, internet facility and software based applications for students to research.

The problems encountered are the smooth flow of internet. There were time constraints. Students had to limit self to the legal issues and societal issues only. Students took their own time to interact because of apprehensions and were not prompt as they are yet not well versed with the administrative process and the procedural laws concerning the nation. The standard parliamentary debate format is easily modified to include public participation in the discussion which is a huge challenge.


GUEST LECTURE ON Expectation Management and Challenges of a Corporate Lawyer



"First Responders and Challenges to Mental Health Maintenance" 13th May, 2020








REPORT OF NATIONAL WEBINAR ON "INTRODUCTION TO THEORIES OF JUSTICE"







Day 3: Induction 05.09.2020



Workshop on Research Methodology Topic "Stages of Research" 12th September, 2020







Workshop on Research Methodology






