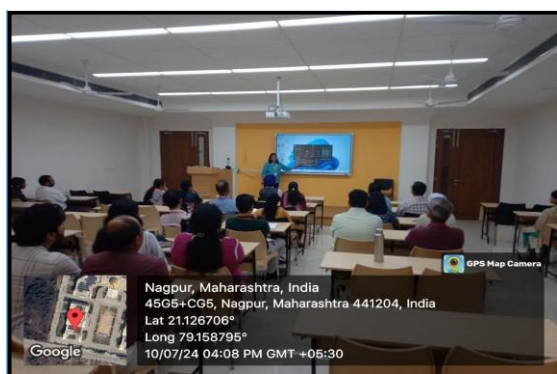

A Two-Day Workshop on White Collar Crimes: Unpacking India's Criminal Law Reforms in Collaboration with The Mentorship Project

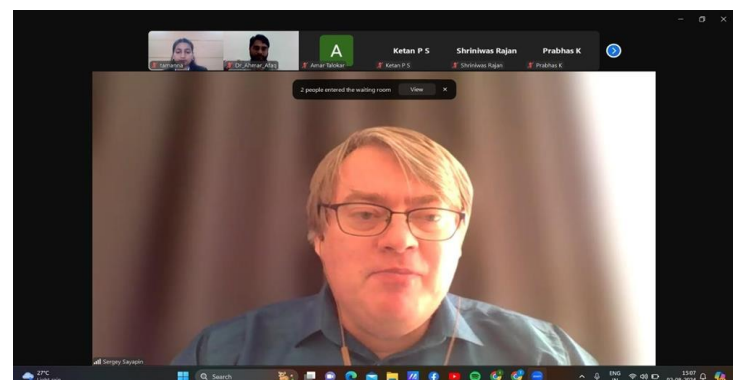

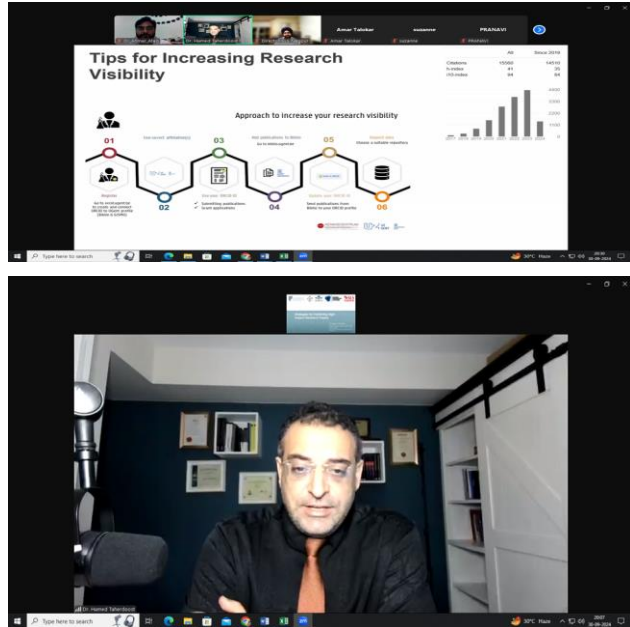
Symbiosis Law School, Nagpur Organised EDGE: A Placement Ranking Competition
