Mr. Vijay Bhise educated students on the **rising threats of cybercrime**, focusing on two key categories: **financial crimes** and **social media-related crimes**.





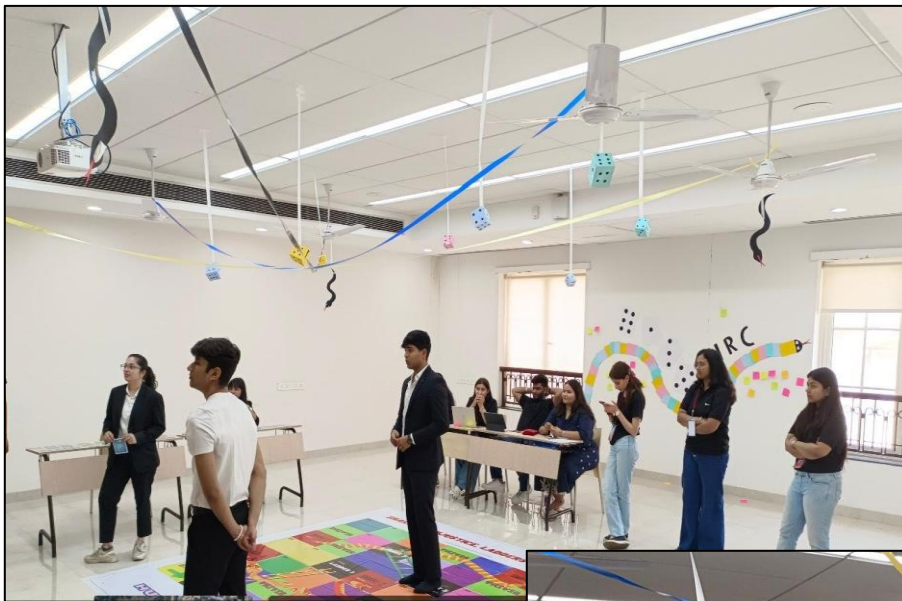

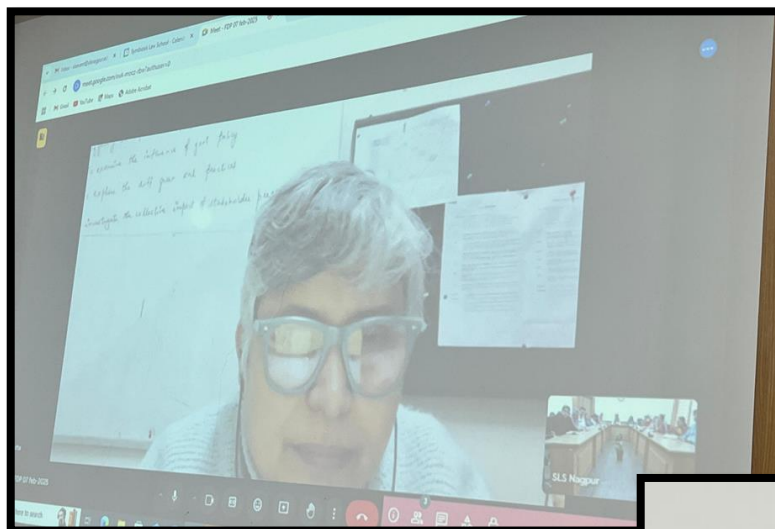


FACULTY DEVELOPMENT PROGRAM

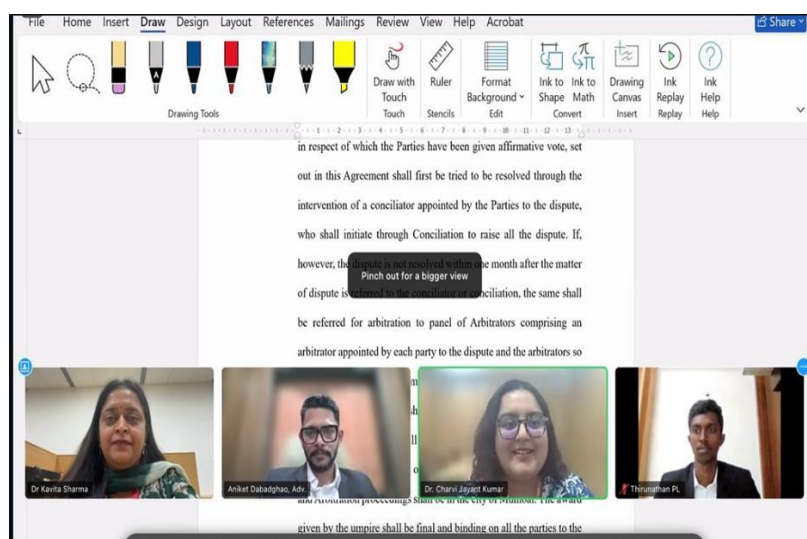


WORKSHOP ON 'DRAFTING AN ARBITRATION AGREEMENT'

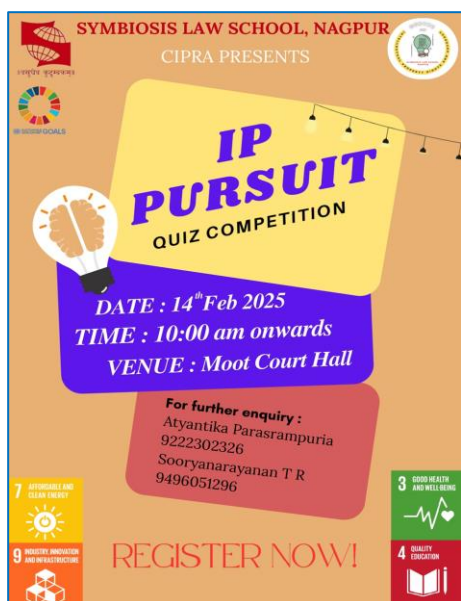

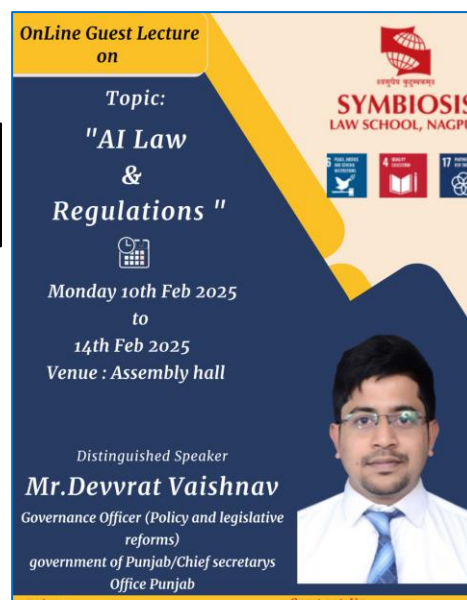


ONLINE GUEST LECTURE ON AI LAWS AND REGULATIONS

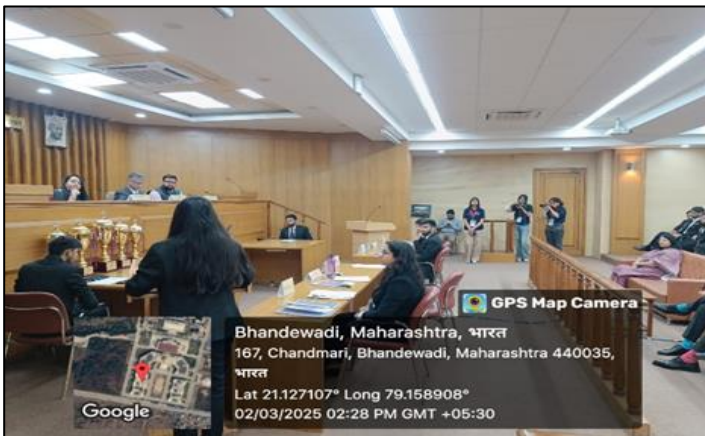

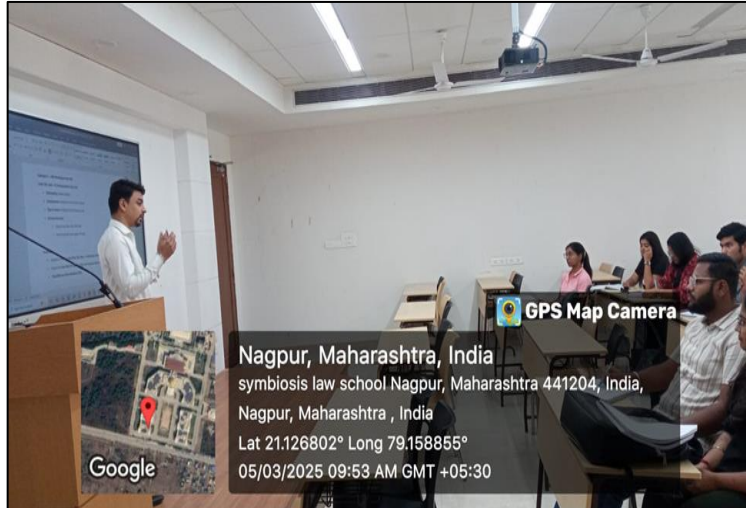

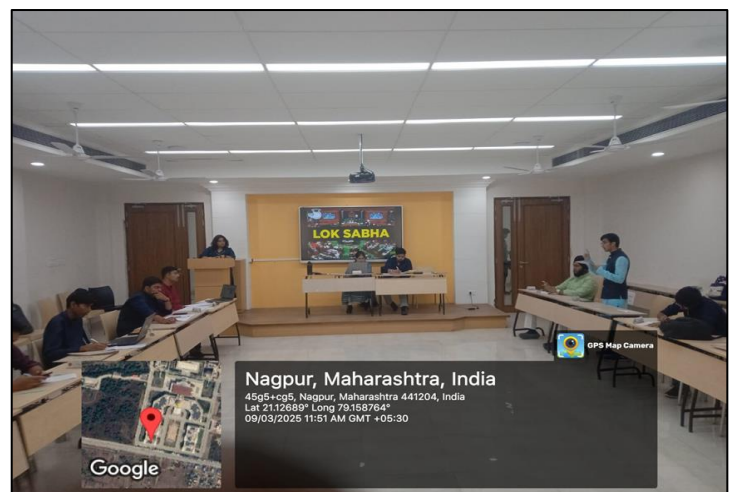

Celebrating International Women's Day with cake Cutting

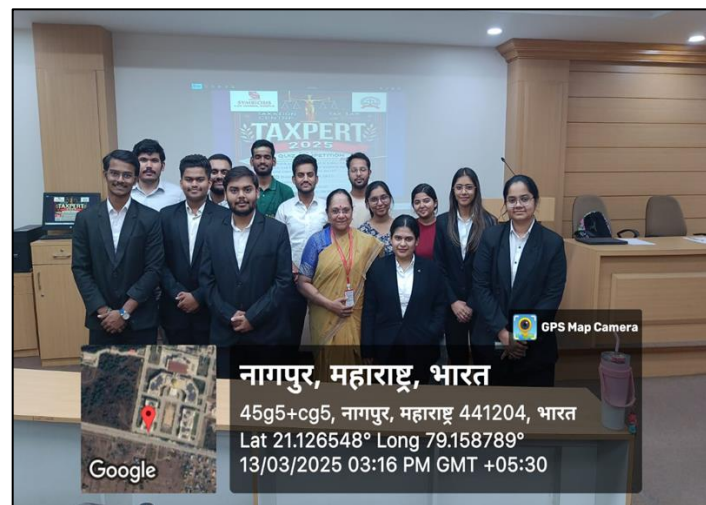

The marking criteria focused on accuracy of legal knowledge, research proficiency, and citation skills, highlighting the participant's ability to reference statutes accurately.

The researcher's test played a significant role in determining the overall performance of the teams, as it reflected their preparedness, depth of legal understanding, and analytical capabilities, which are essential for the upcoming advocacy competition of 2nd intra-trial advocacy, 2025.

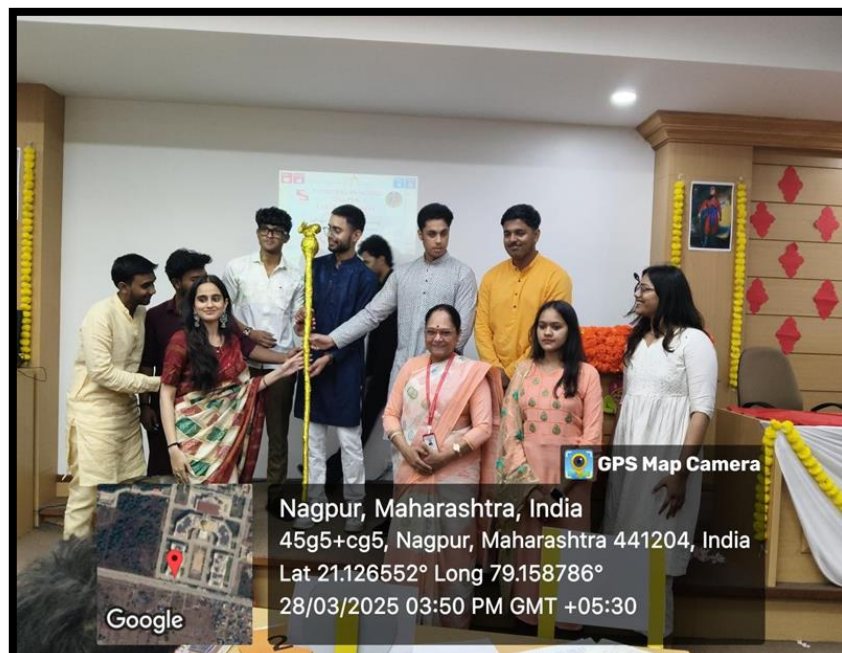

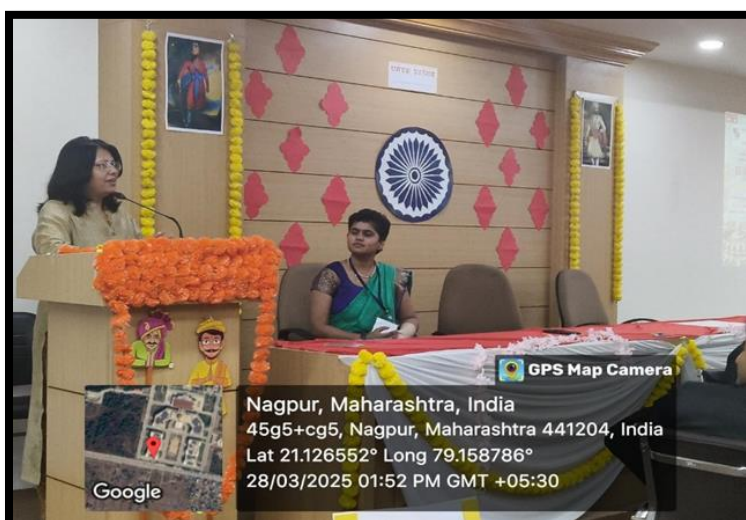

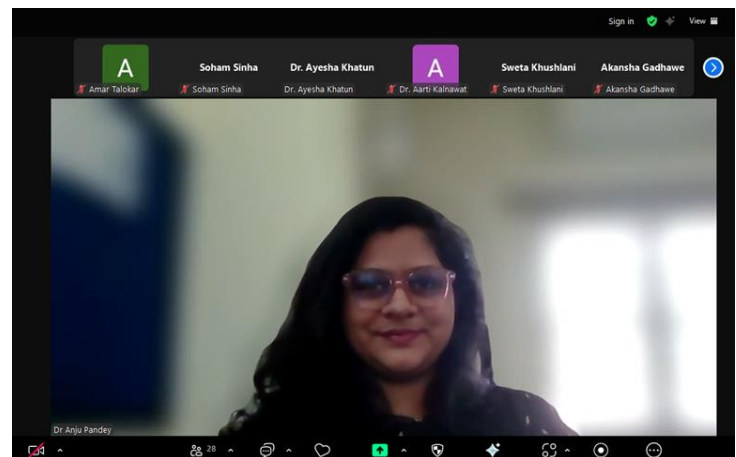
ALUMNI SESSION ON HOW TO SECURE INTERNSHIPS AND PLACEMENT
