On the 12th and 13th of April 2025, the Student Council of Symbiosis Law School, Nagpur, in collaboration with the Sports Cell, organized one of the most awaited and electrifying sporting events of the year — the Attorney's Cup 2.0. With the spirit of unity, discipline, and competitiveness at its core, the tournament served as a vibrant reminder that legal minds can be just as fierce on the field as they are in the courtroom. The Attorney's Cup was conceptualized as an intra-college cricket tournament and featured two highly competitive divisions — Men's and Women's — each designed with its unique format, fostering inclusion and enthusiasm across all batches.

A distinctive and much-talked-about feature of this year's edition was the Auction Ceremony, held on 2nd April 2025 at 4:00 p.m. in the Assembly Hall. Organized ahead of the main event, the auction was open to all registered players from both divisions. It offered captains the opportunity to bid strategically and assemble well-balanced teams, injecting an element of anticipation and professionalism into the tournament. The format, reminiscent of popular league auctions, fostered excitement and gave participants a real-time experience of teambuilding and sports management. This auction brought in a wave of strategic anticipation, as captains and teams meticulously selected players, echoing the thrill of professional league auctions. It not only added a competitive edge to the tournament but also generated immense excitement among students and supporters alike.

The tournament witnessed a phenomenal turnout, with six teams competing in the Men's Division and three teams in the Women's Division. Across two action-packed days, each team showcased remarkable skill, collaboration, and sportsmanship, bringing immense energy and spirit to the campus. The matches were played in a single-wicket format using red and green tennis balls for the men's and women's games respectively, ensuring safety and swiftness in gameplay.

In the Men's Division, teams engaged in a league-cum-knockout format. The first day consisted of six fiercely contested league matches, which determined the top four teams based on points and net run rate. On the second day, the top teams clashed in two intense semi-final matches, eventually leading to the much-awaited final showdown, which was followed by the closing ceremony. Each inning was restricted to eight overs per side, complete with powerplays, fielding restrictions, and super-over provisions in case of a tie, adding layers of strategy and thrill to the games.

The Women's Division featured a fast-paced, knock-out format, played in 5-over matches across two days. The three participating teams — Lady Liberties, Barrister Belles, and Emerald Eagles — gave their absolute best in back-to-back matches, displaying grit, enthusiasm, and exceptional coordination. The final match, held on Day 2, was a culmination of high energy and tactical play, delivering a powerful end to the tournament for the women's contingent.


